(c) Indigenous steel consumption of mild steel for the year 1968-69 was round 4.5 million tonnes. Regarding estimates of domestic demand in 1973-4 the Steering Group has placed it at 7.1 million tonnes per annum.

(d) Plans are being drawn up to achieve self-sufficiency as far as possible. The proposals under consideration include:

1. Completion of the project already in hand and to secure the optimum output from the existing facilities through introduction of technological improvements, additional balancing and finishing facilities to be progressively implemented over the next 10 years.
2. Continuation of Bokaro to 4 MT stage.
3. Bhilai's expansion to 4.2 million tonnes for the production of billets and plates.
4. Additional capacity in steel of about 4 million tonnes in new steel plants.
5. Cold rolled grain oriented sheet plant at Rourkela.
6. Stainless steel cold rolling complex at ASP, Durgapur and doubling the capacity of the plant.

UNRECOGNISED COORDINATION BODY IN SEALDAH DIVISION

456. DR. DEBIPRASAD CHATTO-PADHYAYA: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that an unrecognised body known as the "Coordination Committee" is functioning in the Sealdah Division of the Eastern Railway and is being entertained by the local railway administration;

(b) whether it is a fact that under pressure and coercion brought to bear upon the Administration by the "Coordination Committee" several demands have been conceded in violation of existing rules and norms;

(c) whether it is a fact that due to gheraos and other violent activities of the "Co-ordination Committee", Railways have suffered loss or damage to property; and

(d) if so, what action the Railway Administration propose to take to stop such interference of outsiders while two recognised Trade Unions are functioning in the Railways?

THE MINISTER OF RAILWAYS (SHRI GULZARILAL NANDA): (a) While such a Committee is reported to be functioning it is not correct that the local Railway Administration is entertaining this body.

(b) No, Sir.

(c) and (d) There have been some gheraos by persons including Railway employees and Railway property was also damaged in some cases. The Railway Administration cannot take action in these cases against bodies such as Coordination Committees which, as in the instant case, do not even have recognition. On the part of the Railway Administration they always seek the assistance of the recognised Trade Unions on the Railway in such situation and of the State Government for preservation of law and order.
