t[THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a; and (b) Patna, Gaya, Ranchi and Jamshedpur are already air-linked. The possibility of operating an air service to MuzafEarpur is under examination.

- (c) Indian Airlines operate F-27/ Viscount aircraft on the Patna-Kathmandu route. MuzafEarpur airfield is not suitable for either of these aircraft.
- (d) While Indian Airlines operate daily services to Ranchi and -Jamshedpur (Tatanagar), they have no plans at present to airlink Monghyr, Bhagalpur and Dhanbad.]

INSTRUMENTS LYING IDLE IN NATIONAL LABORATORIES AND INSTITUTIONS

Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state:

- (a) whether Ihe attention of the Government of India has been drawn to a report appearing in the Statesman dated the 1st January, 1970 to the effect that important instruments worth several crores of rupees are lying idle in National Laboratories and research institutions; and
- (b) if so. thi details thereof and the reaction of Government in this regard?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (PROF. V.K.R.V. RAO: (a) and (b) On the basis of a sample survey conducted in 1966 by the Council of Scientific and Industrial Research for the Planning estimated Commission it was instruments/equipment worth about 53.00 lakhs were not in' immediate use in the National Laboratories/Institutes. Basing oni this data, the Central Scientific Instruments Organisation (CSIO). Chandigarh roughly extrapolated the cost of instruments/equipment lying unused in research institutions, universities' HTsi/Eng sneering Colleges, Hospitals, Government Departments etc. for want of repairs at about 4 to 5 crores. The CSIO has not conducted any survey in this regard separately.
