THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) Yes, Sir. During the three years unemployment among engineers has increased.

(b) In May 1968, Government initiated certain measures designed to create additional employment opportunities for engineers. A list of these measures was placed on the Table of the House in answer to Question No. 61 on 24th July, 1968. Both the Central and State Governments have been implementing these measures. statement indicating the progress made in the implementation of these measures is laid on the Table of the [See Appendix LXXI, Annexure No. 41.]. It has not been possible to estimate precisely the number of engineers who have secured employment as a result of implementation of these measures. However, as can be seen from the statement laid on the Table of the House, a significant number of engineers have secured employment as a result of these measures.

(b) At the 1971 Census enumeration, which will be carried out in

February-March 1971, with the reference date as sunrise of 1 March 1971, the basic enumeration Schedule, called the Individual Slip, will collect data on the following:

- 1. Name.
- 2. Relationship to Head of Household.
  - 3. Sex.
  - 4. Age.
  - 5. Marital Status.
- 6. For the currently married women, the age of marriage and if a child born in the last one year.
  - 7. Details of birth place.
- 8. Details of place of last residence.
  - 9. Duration of current residence.
  - 10. Religion.
- 11. If belonging to Scheduled Caste or Scheduled Tribe.
  - 12. Literate or otherwise.
- 13. Educational level and detailed particulars of graduates and technical diploma or degree holders:
  - 14. Mother tongue.
  - 15. Other Languages known.
- 16. Main Activity—If economically active, details of industry, occupation and class of worker:

If economically not active, if the Individual attends to household duties or is a student, a rent receiver or retired person, dependent, beggar or vagrant inmate of a charitable of panel institution and others such as those unemployed and seeking work.

17. Secondary economic activity, if any,

A population Record prepared at the Census enumeration gives the particulars of the composition of each household.

Preliminary to Census enumeration, during 1970 all houses are numbered and listed when data are collected on the following:

(i) Census Houses—material of roof and wall, use of the Census house, number of rooms occupied by a household, number of persons living in the house and tenure status; and (ii) Establishments—whether manufacturing, trading or others; whether Government, Private or Cooperative Institutions; average number of persons working daily; in case of manufacturing Establishments further details like description of the goods produced, and type of fuel used and in case of trading establishments the type of goods bought and sold and whether on wholesale or retail.
