- (a) whether Government's attention has been drawn to the reported thaw in the Sino-U.S. relations; and
- (b) if so, what is Government's assessment of its impact in Asia?

THE DEPUTY MINISTER IN THE OF EXTERNAL AF-MINISTRY (SHRI SURENDRA PAL FAIRS SINGH): (a) and (b) Government is aware of a series of measures recently taken by the U.S. Government to improve relations with China but there has so far been no indication of any response to these measures on the part of China. It is too early to expect to see any impact of this development on Asia as a whole.

CHEAP PROCESS OF MAKING NUCLEAR ROME

PRIME MINISTER ANDMINISTER OF ATOMIC ENERGY GANDHI): INDIRA (SHRIMATI (a) There have been reports about the theoretical possibility of making a cheap Hydrogen Bomb by replacing the fission trigger with a very powerful laser beam. Work has also been undertaken on the centrifugal process for the separation of the fissil isotope of uranium. If successful, these may reduce the cost of nuclear weapons in future.

Government's nuclear change in

policy, Government believe that the present policy of developing our scientific and technological capability in expanding our programme for the peaceful uses of atomic energy is in the best overall interest of the nation. However, in this matter, as in others, Government keep their policy under constant review taking into account the needs of our national defence and security.

RAO): (a) and (b) With a view to accelerating the work on selected major projects which are in an advanced stage of construction, it has been agreed to assist the Government of Kerala in increasing the outlay on Pamba and (b) If by "defence strategy" the Kuttiadi irrigation projects in 1969-Honourable Member has in mind 70 by Rs. 75 lakhs each, and on minor irrigation by Rs. 50 lakhs.
