RECRUITMENT OF OFFICERS FOR ANDAMAN AND NLCOBAR ISLANDS

966. SHRI A. P. CHATTERJEE : Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether (he Union Government depute officers to the Andaman and Kicobar Islands only from the DFIANI cadre;
- (b) whether the population of the Islands is drawn from the various States of the country, particularly South Indian States and West Bengal; and
- (c) whether Government propose to recruit officers from the various States for the Islands instead of deputing officers only from the DFIANI cadre?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) to (c) The population of the Andaman and Nicobar Islands consists of persons drawn from the various States on the mainland, in addition to a sizable number of persons who are permanent residents of the Islands. As it was becoming increasingly difficult to find suitable administrative and Police officers for service in the Islands, senior posts required in the Islands were included in the Union Territoties cadre of the Indian Administrative Service/Indian Police Service, and in the DFL\NI Civil/Police Service Similarly, senior posts in the Forest Department were included in the Union Territories cadre of the Indian Forest Service and post of doctors in the Medical Department were included in the Central Health Service. With regard to other services, recruitment is made in accordance with the Recruitment Rules which, inler-alia provide for deputation from State Governments and Central Govt. Departments. This arrangement is working satisfactorily and no change is considered
