THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH): (a) and (b) According to the information with the Government no large gang of underground Nagas has gone to China during the last 12 months.

- (c) About 275 China returned Nagas have been taken into custody.
- (d) and (e) Government are aware of Phizo's contacts with the Chinese Embassy in London. Government have, in the past, mentioned to the Government of U. K. that as Phizo was a British subject, we hoped that he would not be allowed by the British Government to indulge in activities detrimental to India's interests.

FORCIBLE DISLODGING OF INDIANS IN PAKISTAN

*393. SHRI GANESHI LAL CHAU-DHARY: Will the Minister of EX-TERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the Indians in Pakistan are being dislodged forcibly by the Pakistani residents in Chittagong, Rajshahi and other divisions in East Pakistan and that Pakistan Government declared property which belongs to the Hindus of this area as enemy property; and
- (b) if so, what steps Government of India are taking in the matter?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH):
(a) There have been some cases of forcible eviction of Hindus living in East Pakistan and of declaration of their property, by the Government of Pakistan, as enemy property.

(b) We have often lodged strong protests with the Government of Pakistan and have repeatedly reminded them of their obligations towards the minorities under the Nehru-Liaquat Pact of 1950.

- (a) the names of places in the country where resources of atomic energy are available and the manner in which they are being utilized;
- (b) whether it is a fact that raw materials like Uranium and Thorium are available in the State of Bihar; but they have been declared as uneconomical and are not being exploited; and
- (c) the amount of money allotted for their development work during the Fourth Five Year Plan period and the amount proposed to be spent in Bihar for this purpose?]

†[THE PRIME MINISTER (SHRI-(ATI INDIRA GANDHI): (a) and b) Uranium deposits mainly of uranite have been found in the Singhbhum hrust Belt of Bihar. These deposits t Jaduguda are being commercially exloited by the Uranium Corporation of ndia Ltd., which is a Public Sector Indertaking under the Department of stomic Energy. Exploratory work to rove the reserves is being undertaken t Bhatin and Narwapahar near Jadu-Other occurrences of uranium nd beryl located in Bihar, Himachal radesh, Uttar Pradesh, Tamil Nadu, Aadhya Pradesh and Orissa are also eing investigated. Minor occurrences ave been found in scattered localities n Bihar, Rajasthan and Madhya Praesh. Other atomic minerals including nonazite in the beach sands on the Cerala and Madras coasts are being rocessed by the Indian Rare Earths imited, which is also a Public Sector Indertaking under the Department of the programment of the programment of the control of the programment of the progra Atomic Energy. As stated, the monaite deposits in Bihar are not being exploited as the present requirements are dequately met from more economic deosits found in the beach sands.

(c) An amount of Rs. 220 lakhs is proposed to be spent in Bihar for the survey, prospecting and exploratory development work for the atomic minerals during the Fourth Plan period.]

"NO WAR PACT" BETWEEN SOVIET UNION AND WEST GERMANY

- (a) whether the Government of India have any information about the talks held between the Soviet Union and West Germany for a "No War Pact" and about access to Berlin; and
- (b) if so, what is the reaction of the Government of India in this regard?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH):
(a) Government have been informed that talks are being currently held between the Governments of the Soviet Union and the Federal Republic of Germany on an agreement for renunciation of force. Other related matters concerning Germany will presumably be discussed also.

(b) Government welcome all efforts made to reduce tension in this crucial area in Europe and to renounce the use of force in inter-State relations.
