realise the export targets as may be seen from the following extracts from the Draft Fourth Five Year Plan 1969—74 (P. 93).

"Policy measures, in the first instance, have to be designed to increase the availability of goods for exports. This will call for measures to expand the production base for exports as well as restrain increases in domestic consumption of exportable goods. Fresh investments in export-oriented industries and adequate and regular supply of inputs of right specifications will have to be arranged from domestic or foreign sources."

(d) The detailed steps taken by the Government under the Crash Export Programme as given in reply to part (c) of the Rajya Sabha Starred Question No. 99 laid on the Table of the House on 26-2-1970 have been taken for approximating as nearly as possible the export target. The recent proposals announced in the Budget for 1970-71 tor abolishing the export duty on tea and raising the excise duty on loose and packaged tea with a provision for hoc rebate for exports at rates depending upon the price of tea, reducing the export duty on jute webbings, jute tarpaulins etc. are also expected to help. The broad steps proposed to be undertaken to reach our export targets are indicated in the Draft Fourth Five Year Plan document, pages 93-94.
