NEW STEEL PLANTS IN SOUTH INDIA

1196. SHRI M. K.. MOHTA: Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state:

- (a) whether Government propose to set up some steel plants in South India; and
- (b) whether any decision has been taken in this regard; and if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI K. C. PANT): (a) and (b) Proposals on the location of new Steel Plants are under consideration. A decision is expected to be taken shortly.

BOKARO STEEL PLANT

1197. SHRI M. K. MOHTA: Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state :

- (a) whether Government's attention has been drawn to an article published ia Economic Times dated the 4th February, 1970 to the effect that bad management, wrong construction priorities and unusually long schedules in the construction of the Bokaro Steel Plant has resulted in ;he steep rise in capital-cost of its construction on a turn-key basis by the U.S.S.R.; and
- (b) if so, Government's reaction in regard thereto?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI K. C. GUPTA): (a) and (b) Yes, Sir, but Government do not agree with the conclusions drawn in this article. The Bokaro Steel Project has not been undertaken on a turn-key basis by U. S. S. R. The responsibility for the construction lies with the management of Bokaro Steel Ltd.., while a Soviet organisation has functioned as Consultants.

LOSS IN SOUTHERN RAILWAY

THE MINISTER OF RAILWAYS (SHRI GULZARILAL NANDA): (a) Yes, Sir.

- (b) Loss incurred during 1968-69 was Rs. 15.83 crores.
- (c) (i) The higher proportion of metre gauge to total route length of the Railway, with its higher cost of operation.
