Will the Minister of PETROLEUM AND CHEMICALS AND MINES AND METALS be pleased to state :

(a) whether there have been, for quite some time past, serious differences between

- the Government of India and the foreign oil companies over the price of imported crude oil.
- (b) if so, whether any efforts have been made to resolve the differences; and
 - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI D. R. CHAVAN): (a) Yes.

(b) and (c). The Government asked the foreign oil companies in May 1969 to reduce the price of crude oil imported by them by 10 cents per barrel so as to bring it in line with the fall in the prices of Middle East crudes in world market. On their failure to do so, Government decided to reduce the foreign exchange allocations and imposed a cut of 7\$% on their foreign exchange allocations from 1969. The oil companies reduced the price by 4 cents per barrel only. After waiting for some more time, Government imposed a further cut of 20 % on the foreign exchange allocations with effect from 16-1-70. The oil companies reduced the prices by the further 6 cents per barrel with effect from 1-2-70.
