THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI JAY PRAKASH NARAYAN YADAV):

(a) Yes Sir. In the second meeting of the India - Nepal joint Committee on Water Resources (JCWR) held in October, 2004, it was *inter-alia* decided that a short term strategy identifying the vulnerable areas along various rivers should be jointly worked out on priority for which a Joint Committee was set up to identify the steps that could be taken by both sides to mitigate the devastation caused by the floods.
