The decline is due to the advent of synthetics and the consumer preference for synthetic products. Another contributory factor is the steep rise in the price of husks.

(c) Various steps are being taken to sustain our exports of coir products.

IRRIGATION IN MADHYA PRADESH BY CHAMBAL CANALS

- \*623. SHRI RAM SAHAI: Will the Minister of IRRIGATION AND POWER be pleased to state:
- (a) the area proposed to be irrigated in Madhya Pradesh from the Chambal Canals during the year 1969-70;
- (b) the area actually irrigated during the said period; and
- (c) what is the estimated loss to the cultivators in case there was a shortfall in the actually irrigated area?

THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO): (a) to (c) The area proposed to be irrigated from Chambal Project in Madhya Pradesh during 1969/70 was 2,10,000 acres (which included 25,000 acres of Kharif and 40,000 acres of Mexican wheat). However, on account of difficulties in the running of the Chambal Canals, the area actually irrigated was 1,52,000 acres (which included 25,000 acres of Kharif and 18,000 acres of Mexican wheat). The loss on account of the shortfall in irrigation is being assessed and is roughly estimated as about Rs. 70 lakhs,

(c) Only in the case of sale of sterling tea gardens where remittance in foreign currency is involved, the permission of the Reserve Bank of India is obligatory and was obtained. In case no transaction in foreign exchange is involved, sanction of the Reserve Bank of India prior to sale is not necessary.

A.R.C.), borrowings by State prises and borrowings by F.C.I. and thus help to augment outlays for priority programmes in the public sector. The nationalised banks are also expected to meet the requirements of agriculture, small industry, and small business to a greater extent than hitherto.

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK): (a) TRADE The Minerals and Metals Trading Corporation of India has entered into sale contracts for export of about 2 lakh tonnes of manganese ore to West European Countries during 1970.

(b) and (c) Government have approved 8 barter proposals for the export of high grade manganese ore to USA and Canada.

## RETIREMENT AGE IN ARMY

1474. SHRI M. P. **BHARGAVA:** Will the Minister of DEFENCE be pleased to state:

- (a) whether any decision has been taken regarding the increase of retirement age of various ranks in the army. Navy and the Air Force:
- (b) whether it is a fact that the retiring ages were fixed by the British Government before 1947 and that those have not been reviewed then: and
- (c) whether Government are aware that the retirement age is causing great hardships to Defence personnel in case they are to retire before the age of 50?

THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH): (a) The question presumably refers to the recent revision with effect from 1-1-1970 of the minimum age of retirement in respect of Army Officers of and above the rank of Lt. Col. (other than those who are appointed as Lt. Col by time scale) belonging to the Corps, Infantry, Artillery, the Armoured Engineers and Signals, in accordance with which they are now eligible to serve upto a minimum age of 50 years. The policy in regard to the minimum age of retirement of Officers in the Navy and the Air Force remains unchanged.

- (b) No. The retirement ages of officers in the three services were reviewed on a number of occasions 1947.
- (c) The retiring age is fixed with reference to the requirements of arms and corps and the need for having a cadre of officers and men of appropriate age groups. In determining the terms and conditions of service; this factor is given due consideration.
