Lowering of penalties of companies by Securities Appellate Tribunal

1176.SHRI JIBON ROY: Will the Minister of FINANCE be pleased to state:

- (a) whether in recent past Securities Appellate Tribunal has drastically lowered down the-penalties of some companies that were imposed by SEBI; and
 - (b) If so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SH. S.S. PALANIMANICKAM): (a) and (b) It is observed, from the orders passed by the Securities Appellate Tribunal (hereinafter referred to as "SAT") for the period January to November, 2004 that it has reduced the penalties which

were levied by Securities and Exchange Board of India (hereinafter referred to as "SEBI").

The penalties levied by SEBI have been reduced by SAT, *inter-alia*, on the following grounds:

- (i) Violation being a mere technical breach;
- (ii) Financial capability of the appellant to pay the penalty;
- (iii) Advanced age of the appellant;
- (iv) The order is not workable; and
- (v) None of the factors laid down in section 15J of SEBI Act are satisfied.
