So in political life these things are very common and natural and we should take them as such.

Now, the only distinction which we make between the Radio Peace and Progress and the B.B.C. is that while the Radio Peace and Progress is making commentaries about our political life, the B.B.C. and their T.V. films are attacking our cultural life. That has hurt our feelings. There is no comparison between the two. This kind of thing is very undesirable.

PANT): Sir, in my statement made in the House on 3rd August, 1970 in response to a Calling Attention Notice regarding the burning alive of four Harijans in village Tamdi in district Sambalpur, Orissa, I had stated inter alia that, according to the information received from the Government of Orissa, the assailants were reported to be members of a Scheduled Caste. The State Government have now reported that on further enquiry it has been found that the assailants, who are fishermen, do not belong to a Scheduled Caste, but are treated as a backward class.
