Hospital nd by the Police of Mehrauli
- (b) if so, he contents of the telegram and the action taken by Government thereon:
- (c) whether it is also a fact that the Chairman of the 'Action Committee' ηf Delhi State "Federation Employees Unions" met the Deputy Commissioner of Delhi in the month of July/ August, 1970 along with 2 others and held detailed talks with him in this connection and also showed the said telegram to him;
- (d) if so, the details of talks held with him?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C. PANT: (a) to (d) It is reported that the following telegram was received by Inspector Beneral of Police, Delhi, on 25th July, 19.0:--

"SHRI JAGDISH KIAN BAHUGUNA GENERAL SECRETARY HOSPITAL KARAMCHARI PAN-CHAYAT T. B. HOSPITAL MEHRA-ULI HAS BEEN **THREATENED** FOR THE SERIOUS CONSE-OUENCES BY THE MEDICAL SUPDT, DR. H. B. DINGLEY AND BY THE POLICE OF MEHRAULI THANA(.) PLEASE LOOK INTO THE MATTER FOR THE SAFETY OF SHRI BAHUGUNA IMMEDIA-TELY....PAULUS BIALL PRESI-DENT."

A deputation of the Federation of Delhi State Hospital Employees Unions met the Deputy Commissioner, Delhi, on July 28, 1970, and repeated the allegations contained in the telegram. Acording to the information available with Delhi Administration, allegations against Medical Superintendent of the Hospital and staff Police Station. Mehrauli, are incorrect. However, Sub-Divisional Magistrate, Mehrauli area has been asked by the Deputy Delhi, to make Commissioner, further enquiries into these allegations.
