The following steps have been taken by the D.T.U. to provide transport facilities to the students of the G. B. Pant Polytechnic Institute:

(1) All the buses of routes No. 18A, 24A,' 29A, 43 and 58 reaching Okhla Industrial Estate bus stop between 8.30 and 8.50 hours have been extended to the Central Road Research Institute for
