THE MINISTER OF STATE IN THE INISTRY OF PETROLEUM AND MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS MINISTRY (SHRI D. R. CHAVAN) : (a) Yes. The Government of India have appointed a Drugs Prices Review Board on the 28th July, 1970.

## STATE BANK SCHEME FOR SMALL SCALE USTRIALISTS

1677, SHRI K. L. N. PRASAD: Will the Mirister of FINANCE be pleased to sta

- (a) whether tt is a fact that tlie State Bank of Indu has decided to start a scheme to provide credit facilities to Small-Scale Industrialists to carry out expansion programmes; and
- (b) if so, what are the main features of the schemi?

THE MINISTER OF REVENUE AND EXPENDITURE (SHRI VIDYA CHARAN SHUKLA): (a) and (b) The State Bank oi India has not formulated any separate scheme to finance the expansion prog amme of small scale industries. Hov ever, the bank is already providing ere lit facilities to small scale industries un ler its liberalised scheme, which cover credit requirements for

expansion programme also. Comprehensive credit facilities to meet working capital as well as term loan requirements are provided by the bank. Term loans are provided by the bank for the acquisition of fixed assets such as land, building and plant and machinery. While the normal margins in respect of land and buildings and machinery are 33.1/3% nnd 25% respectively, a reduced ma of 25% is agreed to for construction of sheds in industrial estates. The loans are normally repayable in suitable instalments over a period of 7 to 10 years. fhe rate of interest on these loans is 9% per annum.

## AGREEMENT FOR RE-PAYMENT OF LOANS TO JAPAN

1678. SHRI K. L. N. PRASAD: Will the Minister of FINANCE be pleased to state;

- (a) whether it is a fact that the Government of Japan have recently agreed to the request of the Governmen: of India to defer the repayment of Indian Joans to Japan; and

THE MINISTER OF REVENUE AND EXPENDITURE (SHRI VIDYA CHARAN SHUKLA): (a) and (bi Yes Sir. Four Agreements totalling Rs. 19.06 crores (\$25.41 million) were signed on the 30th July, 1970.

The agreements envisage rescheduling of part of earlier Yen Credits which are due for repayment during 1970-71. The agreements provide for repayment in 12 years, including 3 years' grace, and carry interest at 4% per annum
