(d) if so, the reasons for reconsidering the earlier decision?

THE MINISTER OF REVENUE AND EXPENDITURE (SHRI VIDYA CHARAN SHUKLA): (a) and (b) The possibilities of evolving a scheme intended to depute Government officers be-longing to IAS and other Services at comparatively junior levels to work in and gain experience of Public Enterprises are currently being examined. The scheme is intended to give training to certain number of Government servants in public enterprise type work with three objects in view:

- (i) such training will help civil servants to deal with public sector problems better when they come back to Government.
  - (ii) some of these civil servants who prove successful during such training could be permanently absorbed in Public Enterprises.
  - (iii) some of the civil servants could also be sent to new Public Enterprises to be established during the subsequent Plan periods.

No final decision on this scheme has, however, yet been taken.

- (c) The Cabinet had taken a decision that civil servants deputed to Public Enterprises should be asked to exercise an option either to resign from civil services with a view to permanent absorption in the concerned Public Enterprises or revert to the parent cadre.
- (d) There is no proposal to reconsider this decision of the Government which still stands.
