THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI PAR1MAL GHOSH):

- (a) Yes, Sir, subject, however, to adjustments that may become necessary on account of changes in the road pattern, the existence of pre-February 1967 unauthorised colonies or construction and similar factors.
- (b) Physical possession of land has been handed over provisionally to 6 Co-operative House Building Societies. The work of demarcation of land is in progress and the Delhi Administration expect to hand over physical possessioa of the land to other Societies in the near future.
  - (c) There is no such intention at present.
