

for important foodgrains through fair price shops and arrangement for enlarged imports as in the case of raw cotton and soyabean oil. The procurement operations of the Food Corporation of India are being continued with and the forward transactions in foodgrains remain banned. The stock of foodgrains with the Government amounted to 5.4 million tonnes at the end of June 1970.

The decision to empower the State Trading Corporation to set up an Industrial Raw Materials Assistance Centre to organise bulk import of raw materials for sale to actual users and the proposed setting up of public sector agencies for the import of raw cotton and cashew should also lend further stability to prices.

Besides, the Organisation of the Commissioner of Civil Supplies keeps under constant watch the availability and price trends of 20 essential commodities under the Essential Commodities Act, 1955, necessary powers have been delegated to the State Governments and Union Territories to regulate the distribution and prices of commodities declared essential under that Act.

#### C.B.I. INVESTIGATION INTO THE CONDUCT OF FORMER RESIDENT REPRESENTATIVE OF HYDRO CARBON AT TEHRAN

(a) whether the Central Bureau of Investigation conducted any investigation into the conduct of the former Resident Representative of the Hydro Carbons Private Ltd., at Tehran;

(b) if so, what are the circumstances under which these investigations were conducted; and

(c) what are findings thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI D. R. CHAVAN) : (a) The Central Bureau of Investigation have conducted confidential checks of records and documents regarding certain allegations against the former Resident Representative of the Hydro Carbons India (Private) Limited at Tehran.

(b) The checks were taken up on the basis of allegations received by the Ministry.

(c) On the basis of the preliminary investigations, the C.B.I. have registered a case for making detailed investigations. In view of this it is not in public interest to disclose the findings at this stage.
