THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK): (a) and (c) The guidelines for export policy approved by Government are contained in the Export Policy Resolution which has been circulated to all Members of Parliament.

(b) If those guidelines are followed, the export targets of the Fourth Plan can be achieved.

- (d) whether there is any rule requiring the staff of Indian Missions abroad to use Indian dress, Indian articles and Indian language or the language of the country where they are posted?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH):
(a) While it is not possible for any of our Missions abroad to transact all their official work in Hindi at present, they are endeavouring to do so to the extent required. Efforts will continue towards a gradual switch over to Hindi.

(b) to (d) Indian Missions in their transactions with the foreign Governments use the language of the country to the extent possible.

On ceremonial occasions, Indian officials of Indian Missions abroad are required to wear prescribed Indian dress. Instructions have also been issued that they should use Hindi in conversation amongst themselves and with other Indians, as well as with foreigners who have a knowledge of Hindi. The use of Indian articles is actively encouraged. Several items of official and household requirements are supplied from India.
