- *324. SHRI B. N. MANDAL: Will the Minister of STEEL AND HEAVY ENGINEERING be pleased to state:
- (a) what are the reasons for the large-scale and almost continued acts of indiscipline and strikes in the Durgapur Steel Plant;
- (b) whether any political party is responsible for this situation;
- (c) if the answer to part (b) above be in the affirmative, how Government propose to deal with that party; and
- (d) what is the extent of loss in production in terms of rupees as a result of this state of affairs, during the past two years as well as during the current year so far?]

इस्पात तथा भारी इंजीनियरी मंत्री (श्री बी० आर० भगत): (क) दुर्गापुर इस्पात कारखाने मे लगातार हड़तालों और अनुशासनहीनता के मुख्य कारण, मालिक मजदूर सम्बन्धों का अच्छा न होना, मजदूर संघों में आपसी स्पर्धा, मजदूर सघ के मामलों मे राजनीतिक उद्देश्मों मे लाभ उठाने की प्रवृत्ति आदि हैं।

- (ख) इस स्थिति के लिए किसी एक राज-नैतिक दल को उत्तरदायी नहीं ठहराया जा सकता।

†[THE MINISTER OF STEEL AND HEAVY **ENGINEERING** BHAGAT): (SHRI B. R. Frequent acts of indiscipline and strikes in Durgapur Steel Plant are mainly due to poor indus rial relations, interunion rivalary tendency to exploit trade union issues for political ends, etc.

- (b) No single political party can be held responsible for this situation.
 - (c) Does not arise.
- (d) While it is not possible to assess the extent of loss on account of large scale labour indiscipline exclusively, the total loss in Durgapur aggregated to Rs. 17.37 crores in 1968-69. In 1969-70, the loss is estimated to be about Rs. 14.17 crores. From April, 1970 onwards, it is estimated that the plant is losing Rs. 1.4 crores per month.]

THE MINISTER OF STEEL AND HEAVY ENGINEERING (SHRI B. R. BHAGAT): No specific proposal for setting up a Steel Plant at Bailadilla had been accepted in the past. There is, therefore, no question of dropping such a proposal. Further, as mentioned by the Prime Minister in her statement on the 17th April, 1970, the decision to set up three Steel Plants in the South does not preclude new steel plants being set up at other suitable sites in the future.

CONNECTING OF KHAGRAGHAT STATION WITH BERHAMPORE TOWN EXCHANGE

SASANKASEKHAR 701. SHRI SANYAL: Will the Minister of RAIL-WAYS be pleased to state the steps that are being taken for connecting Khagraghat Railway Station on the Howrah-Farakka line of the Eastern Railway with the Berhampore town exchange of the West Bengal Telephone Circle in view of the fact that the said station is within close reach of the telephone line?

THE MINISTER OF RAILWAYS GULZARILAL NANDA): Even though the Divisional Superintendent, Eastern Railway, Howrah, had placed a demand for a P&T telephone at Khagraghat Road railway station on the P&T as early as March, 1968, the P&T Department were not in a position to provide the connection as the capacity of the Berhampore Exchange was full and in addition the proposal was technically not feasible due to the fact that the existing telegraph posts on both sides of the river Bhagirathi are not capable of taking any additional load. The P&T Department had, however, a proposal for laying telephone cables across the newly constructed road bridge near Khagraghat but this proposal could not be implemented for want of permission from the PWD authorities. It is now understood from the P&T Department that the PWD authorities have since accorded the permission. The Eastern Railway Administration is pursuing the matter with the P&T for early provision of the telephone.
