THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI MOHD. SHAFI QURESHI): (a) and (b) It is a fact that according to the revised distribution policy, despatches of different categories of steel will be regulated by the Steel Priority Committee. It will be for the Steel Priority Committee to decide, having regard to the priority demands, what percentage of production should be allotted to the traders.

(c) As indicated in the Government Resolution itself, in according priority of despatch to the orders booked by any individual consumer on the main producers, the Steel Priority Committee shall utilise, to the extent possible such orders as existed on the date of the Resolution and Priority would be accorded to subsequent orders only when the existing orders placed by a consumer for the category are exhausted.

PRICES OF WIRE ROPES

(a) to (c) From the rate contract en tered into by the DGS&D with 9 wire rope manufacturers for the purchase of wire ropes during the period from 15-5-1968 to 14-5-70 and for the 1-7-70 to 30-6-71, it period from appears that there has been some increase in the price of wire ropes. The items and sizes involved being numerous, the percentage increase varies itemwise. According to the Wire Rope Mnaufacturers' Association, overall average increase over 1968 rates was 36.1% and wherever the percentage increase was higher, it was in respect of items where the demand rather negligible. No was specific complaint has been received that the wire rope manufacturers have formed a cartel with a view to artificially increase the prices. This aspect would be looked into.

THE DEPU 'Y MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOPMENT AND INTERNAL TRADE (SHRI M. R. KRISHNA): (a) to c) Thi Government is not producing pur lping sets and diesel engines in the public sector. There are 30 units in th j large-scale sector with a total annual capacity of 1,26,130 numbers for tl 3 manufacture of diesel engines. 38 units in this sector with an annual capa:ity of 2,62,351 numbers

are producing power driven pumps. There are a few units who are manufacturing both diesel engines as well as pumps. There are also about 319 units manufacturing various types of pumping sets in the small-scale sector with a total annual production of about 4.04 lakh numbers. There are also about 600 small-scale units manufacturing diesel engines up to 5 to 20 HP, besides other products. The major concentration of pump and diesel-engine manufacturing units is in Madras, Gujarat, Punjab, Maharashtra and Haryana. The price for a 3 HP pumping set is about Rs. 2,400 whereas the price for pumping set of 15 HP is about Rs. 6,200.
