Constant interaction with Hindustan Aeronautics Limited (HAL) and Original Equipment Manufacturers (OEMs) of concerned countries are also maintained to overcome the technical defects of aircraft. Besides, anti-bird measures are also undertaken.

#### **Import of High Altitude Operationable Helicopters**

1327. SHRI K. RAMA MOHANA RAO: Will the Minister of DEFENCE be pleased to state:

(a) whether army is importing helicopters designed for high altitude operations from Russia, United States and Europe;

(b) if so, whether Hindustan Aeronautics Ltd. is unable to deliver similar helicopters in the near future and;

(c) when would the HAL be able to build high altitude operationable helicopters?

THE MINISTER OF DEFENCE (SHRI PRANAB MUKHERJEE): (a) There is a proposal to import helicopters to replace Cheetah and Chetak for high altitude operations for which global 'Request for Proposal' (RFP) was issued.

(b) Hindustan Aeronautics Limited (HAL) at present does not manufacture helicopter in the category for which RFP has been issued. The proposal envisages import of some helicopters and Transfer of Technology from the successful vendor to enable HAL to manufacture the helicopters.

(c) HAL will be able to manufacture these helicopters after acquiring the Transfer of Technology.

#### **Setting UP of a Group for More Private Participation in Defence Production**

Kelkar, Ex-adviser to Finance Minister, to examine and make recommendations to ensure effective participation of private sector in Defence Production.

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI B.K. HANDIQUE): (a) and (b) After opening Defence Production for private sector participation in May 2001, 42 applications have been received from private companies for manufacture of various types of defence equipment. Against these, the Department of Industrial Policy & Promotion (DIPP), in consultation with the Ministry of Defence, has so far issued 18
