†[SETTING UP OF A REFINERY IN SWAI MADHOPUR

SHRI MAN SINGH VARMA : Will the Minister of PETROLEUM AND CHEMICALS AND MINES AND METALS be pleased to state :

(a) whether it is a fact that there is a proposal under Government's consideration to set up a refinery in Swai Madhopur; and

(b) if so, what are the reasons for the delay in the implementation of this proposal ?]

DEMAND AND SUPPLY OF DYE VATS AND SODA ASH

*383. SHRI B. V. ABDULLA KOYA : Will the Minister of PETROLEUM AND CHEMICALS AND MINES AND METALS be pleased to state :

(a) whether Government have assessed the gap between the demand and supply of Dye Vats and Soda Ash in the country during the current year; and

(b) if so, the steps taken to bridge this gap ?

THE DEPUTY MINISTER IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI BHANU PRAKASH SINGH) : (a) Yes, Sir.

(b) Present production of soda ash will be sufficient to meet current demand. In regard to vat dyes there is sufficient capacity approved to meet the Fourth Plan target of 1600 tonnes. The production however is currently less than the capacity approved, and the gap between the production and demand is being met by imports.
