Public Undertakings engaged in mining and development work of minerals, is being ensured by State Programming Boards and, Central Geological Programming Board. Be sides the All India Mineral Advisory Board deals with major questions of the working of mining laws and procedures and various development measures which would facilitate the increased utilisation of minerals resources.

The first boards have to decide with the help of the Custodians various administrative matters relating to the banks and need to have frequent meetings. As each of the first boards is small in size the directors are normally expected to attend all meetings of the board. It may be mentioned that
