- (c) During the period January-June 1970, complaints of 46 consignments were received. Of these, a large number relate to export products which are not so far covered for compulsory quality control under the Export (Quality Control and Inspection) Act, 1963. Viewed against the volume of exports these complaints are insignificant.
- (d) So far compulsory quality control and/or pre-shipment inspection has been enforced over nearly 300 export commodities. Progressively, more and more export products are being covered under compulsory quality control and pre-shipment inspection schemes.

The pre-shipment inspection machinery is being continually geared to meet with the requirements of compulsory inspection. However, as such inspection is done on the basis of samples drawn at random from the export cargo, the possibility of some subquality export products passing through could not be ruled out.
