

†[OFFICE OF THE R.S.S. IN THE PREMISES OF BANARAS HINDU UNIVERSITY

1073. SHRI SURAJ PRASAD : Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state :

(a) whether it is a fact that the office of the Rashtriya Swayam Sevak Sangh is located within the premises of Banaras Hindu University and that it has not been removed from there so far;

(b) if so, what are the reasons therefor; and

(c) what steps are being taken to remove the said office from there ?]

शिक्षा तथा युवा सेवा मंत्री (प्रो० बी० के० आर० वी० राव) : (क) जी, हां। बनारस हिन्दू विश्वविद्यालय के अहाते में दो कमरे वाली एक इमारत राष्ट्रीय स्वयं सेवक संघ के कब्जे में है।

(ख) और (ग) : विश्वविद्यालय के प्राधिकारी इमारत को सौहार्दपूर्ण ढंग में खाली कराने के लिये राष्ट्रीय स्वयं संघ के कई स्तरों के नेताओं से बातचीत करते रहे थे, परन्तु कोई समझौता न हो सका। विश्वविद्यालय की कार्य परिषद् ने अपनी 25 जुलाई, 1970 को हुई बैठक में उस अनुमति को, जिसके द्वारा राष्ट्रीय स्वयं सेवक संघ इस इमारत को उपयोग में ला रहा है, रद्द करने के लिये सर्वसम्मति से एक संकल्प पास किया था। कार्य परिषद् के संकल्प को कार्यान्वित करने के लिये विश्वविद्यालय उचित कार्यवाही कर रहा है।

†[THE MINISTER OF EDUCATION AND YOUTH SERVICES (PROF. V. K. R. V. RAO) : (a) Yes, Sir, the R.S.S. has in its possession a two-roomed building in the campus of the Banaras Hindu University.

(b) and (c). The University authorities had been negotiating with the leaders of the R.S.S. at various levels

for vacation of the building in an amicable manner, but no agreement could be reached. At its meeting held on July 25, 1970, the Executive Council of the University unanimously passed a resolution revoking the permission by which the R.S.S. is using this building. Suitable action is being taken by the University to give effect to the resolution of the Executive Council.]

Will the PRIME MINISTER be pleased to state :

(a) the steps taken by Government by providing employment to Engineers and other kinds of technical graduates; and whether any appreciable percentage of unemployment has declined by adopting such measures; and

(b) what is the total number of such unemployed persons upto June 30 1970 ?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C. PANT) : (a) Government initiated in May 1968, a number of measures to augment employment opportunities for engineers and Central Ministries and State Governments were requested to implement the same. A statement detailing the progress made in the implementation of these measures was laid on the Table of the House in answer to Unstarred Question Number 420 on the 4th August 1970.

It is difficult to assess precisely the additional jobs created as a result of these measures. However it would be seen from the statement referred to that these measures have yielded appreciable results.

Government have also initiated some steps to enlarge employment opportunities for agricultural engineers, agricultural graduates and other technical personnel in the rural areas. A statement enumerating these steps is attached. (See below) These measures have been initiated recently and it is too early to assess the impact of these measures.

(b) Information relating to the total number of job seekers on the live registers of employment exchanges as on 30th June, 1970 will be available shortly. However, the number of job seekers registered with the employment exchanges in the country as on 31st December, 1969 indicates that there were 13,101 engineering graduates (including post-graduates), 44,733 engineering diploma holders and 5,646 graduates and post-graduates in agriculture on the live registers of the employment exchanges.
