- (2) Pre-entretest should be introduced for adm ssion to the Lady Hardinge Medical College from this year and 50% sents should be reserved for Delhi students and the rest 50% for candidates from the other States.
- (3) The metit list for admission to All India Institute of Medical Sciences New Delhi, should be based on the results of the Pre-entry test. No weightage should be given to the previous academic record of the students because the standards of the Universities are not uniform.
- (4) Seats in Maulana Azad Medical College, Lady Hardinge Medical College and All India Institute of Medical New Delhi, should be increase I to accommodate students who have passed Pre-medical examination from Delhi University.
- (c) It has already been decided to increase admiss ons at Lady Hardinge Medical College b 10 seats and all these seats have been earmarked for Delhi students apart from 13 already reserved for them. It is further proposed to raise the annual admission capacity of the Maulana Azad Medical College and the Lady Hardinge Medical College. The matter is under consideration of the University of Delhi, The University of Delhi have, however. not found it reasible to start a second shift in Maulana Azad Medical College.

As regards the holding of a Pre-entry test to the Lady Hardinge Medical College it not be fin ilised by the Delhi University in time this year; but it will be pursued with the Delh University again. The other point is under consideration of the Government.

REDUCTION IN PRICES IN LIQUID AMMONIA SUPPLIED BY IRAN

- (d) whether the Government of Kuwait has agreed to supply liquid ammonia for use in the Trombay fertilizer at 75 cents less than the price demanded by the Iranian Government?

CHAVAN) AND (a) No. During the course of negotiation with the Indian Petro-chemical company of Iran, the Fertilizer Corporation of India have been able to secure reduction in the price of ammonia for the use of fertilizer plants in India.

(b) to (d) Government have approved the Fertilizer Corporation of India purchasing one million tonnes ammonia from the National Petro-chemicals Company of Iran and 5,00,000 tonnes of ammonia from the Petro-chemical Industries Company of Kuwait during the period from 1972 to 1978. It is not in public interest to disclose the price at which the Corporation will purchase the ammonia from Iran and Kuwait. As far as it is known, there is no international price for ammonia.
