- (iii) Study on the possibility of operating Chasnalla Washery as a Central Washery with coals obtained from outside unitl the linked mines are in production;
- (iv) Suggest measures for the economic utilisation of washing capacity, consistent with the demand for washed coals,
- (v) Study and recommend the levels to which coals are to be washed;
- (vi) Recommend the additional washing capacity that will have to be set up having regard to the demands from metallurgical/ future industries; and
- (vii) Suggest measures for the use and linkage of washery middlings with thermal power stations.
- 2. The Committee will submit its report within six months.

- (a) whether Government's attention has been drawn to a news-item published in the Hindustan Times dated the 18th December, 1969 to the effect that the after-effects of pencillin can be fatal; and
- (b) if so, what is the reaction of Government thereto?]

(b) It is known for a long time that Penicillin can produce a fumber of allergic reactions in the human body which may even cause death. However, Penicillin is a very useful and life saving drug. Its use by qualified persons, who are aware of the adverse reactions, is as safe a procedure as the use of many other life saving drugs. Instructions have been issued about the precautions to be taken and about the way in which reactions should be treated.1

THE MINIS' ER OF STATE IN THE MINISTRY (F PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI D. R. CHAVAN) : (a) 290 tonnes equivalent to 3,70,000 Mlrds.

- (b) and (c) Yes. The Soviet Delegation which visited the Plant during September/ October, 1969 r viewed the capacity alongwith the India Specialists in the light of past perfor nance and assessed it at 315,000 Mlrds. as against 254,500 Mldrs. assessed by the Indian Specialists.
- (d) and (e) Procaine Penicullin: The question is still under discussion.

Chlorotetracycline: In view of the declining demand for this item, the question whether or not to produce this antibiotic is being re-con idered.

Nystatin: The production is yet to be established.

Streptomycin: As the Dehydro-streptomycin has become obsolete, it has been decided to use the production capacity for the production o streptomycin sulphate.

(f) and (g) Since the collaborators are supplying the b lancing plant and equipment and rend ring the technical advice, to attain the a cepted capacities, free of cost, the question of payment of compensation by them does not arise at present.

### IRON OR FINES AT RASTAR

\*490, SHRI EAM SAHAI: Will the Minister of PLTROLEUM AND CHE-MICALS AND MINES AND METALS be pleased to state:

- (a) whether it is a fact that Bailadilla Iron Ore Projet, Bastar has ample iron ore fines and th y are not being made use of for any purpose at present;
- (b) whether the National Mineral Development Corporation have under consideration to set up a Pelletisation Plant at Bailadilla in he public sector to make use of these fine; and
- (c) if so, when is it proposed to set up this Plant?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SUR) ATTEMPT OF STATE IN THE TALS (SHRI MITIRAJ SINGH CHAU-DHARY): (a) Iron ore fines are generated in the course of mechanised mining and processing of iron ore at Bhailadila Deposit No 14, where a mine has been

developed by the National Mineral Development Corporation Ltd., for the production of lump ore for export to Japan. These fines are now being accumulated pending finalisation of arrangements for their dis-

- (b) The National Mineral Development Corpn. Ltd., has commissioned a technoeconomic feasibility study on the establishment of a pelletisation plant based on iron ore fines and blue dust being produced in Bhailadila.
- (c) An investment decision on the establishment of the plant can be taken only after examining the feasibility report.

### GROWTH-RATE OF BANK DEPOSITS

- \*491. DR. BHAI MAHAVIR: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that the growth rate of bank deposits in India which was 11.4 per cent before nationalisation of banks has come down to 10 per cent at present;
- (b) if so, what are the reasons for the decline; and
- (c) what steps are being taken to improve it?

# STATEMENT

During the year July 19, 1969 to July 17, 1970 aggregate deposits of schedule commercial banks have increased by 14% as against 16.4% during the corresponding period of 1968-69.

The slower pace of deposit growth is is attributable partly to the smaller extent of deficit finacing by the Government. Besides, the recent rise in prices and recovery in industrial and training activities this year are also believed to have affected deposit growth adversely.

The relatively slow growth of deposits has been a matter of concern to Government and pointed attention of the concerned banks in the public sector has been drawn to this. They have been advised to initiate campaigns for deposit mobilisation and to introduce new schemes for attracting deposits. Measures for stepping up deposit mobilisation were considered at the Finance
