with the Government of Pakistan who are really the authorities responsible in this regard.

(c) There are severe restrictions on the movement of our diplomatic pei-sonnel in Pakistan. Besides, it is not possible for a diplomatic mission to engage in activities which the host Government may claim as impinging upon their sovereignty.

INDIAN ASSISTANCE TO DEAL WITH NAXALITE PROBLEM ON BHUTAN BORDER

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): Yes, Sir; in order to prevent its extension to or infiltration into Bhutan.

The substance and details of these contacts are confidential. It is our view that substantive progress in the Paris talks, and the discussions among the parties in Laos offer the best opportunities at present for progress towards a peace settlement in Indo-China.
