(c) whether any unemployment problem had been solved as a result of the suggestions of the Committees; and

(d) if not, the reasons for appointing a new committee for this purpose?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI D. SAJIVAYYA): (a) Government have decided to set up an Expert Committee on Unemployment to assess the extent of unemployment in all its aspects and to suggest suitable remedial measures.

(b) to (d) The Planning Commission had set up in August, 1968 a Committee of Experts on Unemployment Estimates under the Chairmanship of Prof. M. L. Dantwala to enquire into the estimates of unemployment worked out for the previous Plans and the data and methodology used in arriving at them, and to advise the Planning Commission in various connected issues. The Committee has recently submitted its report which is under consideration of the Planning Commission.
