(b) A Technical Committee comprising of 17 members inrluding the representatives of the Sugar Ind istry and the Sugar Mill Machinery Ma lufacturers was appointed in July, 1970 for reviewing the standard specifications for stil ar planls drawn up earlier in 1964, in the li,'ht of the developments that have since taki n place in technique and de sign features n some equipments. The Committee has ben asked to submit its report within a peric 1 of six months.

FUNCTIONIP OF TRUNK TELEPHONES STEM IN DELHI

1254. SHRI K.L.N. PRASAD: Will the Minister of INFORMATION AND BROAD CASTING AND COMMUNICATIONS be pleased to state:

- (a) whether it is a fact that there bad been large complaints from the members of Parliament and by the general public regarding working of the present Trunk telephone system in Delhi;
- (b) whether it is also a fact that booking a call from Delhi to other States takes a whole day and even then there is a virtual state of uncertainty as to whether the call would materialise at all;
- (c) whether Government are aware, that the newly introduced system of Trunk Calls in Hyderabad has been working satisfactorily;
- (d) if so, whether in view of its successful operation, Government are considering to introduce such scheme in Delhi also;
 - (e) if not, the reasons therefor; and
- (f) what steps are being taken to make the Trunk Calls system more efficient and to the satisfaction of the people in Delhi and other cities?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (PROF. SHER SINGH): (a) No. Sir.

- (b) No. The answer on trunks booking is mostly within the prescribed standard of 10 seconds. Regarding trunk calls to mature. it may be mentioned that generally there is hardly any delay for transmission on direct routes except when there is breakdown in the coaxial cable system. However for transit calls and the terminal calls on side routes much depends upon the functioning of the circuits and quantum of traffic. Most of the open wire routes are prone to the wire thefts.
- (c) According to the information available the only difference between the working of Delhi trunk exchange and Hyderabad trunk exchange is that at Hyderabad they are resorting to non-revertive system for dealing with enquiries on 181 while in Delhi the subscribers are rung back to give them the desired information.
- (d) Non-revertive method is not considered suitable for Delhi where more than 90% of the queries are answered within 3 minutes through the existing method of working.
- (e) Hyderabad system being a smaller one can successfully follow the non-revertive method whereas in Delhi this system will involve provision of additional positions and additional staff. In addition to this there is a large number of M.Ps and VIPs at Delhi who will find it inconvenient to hold the line till the information is collected and passed on to them.

(1) The present procedure adopted for handling trunk call enquiries has enabled the authorities to dispose of 90';, enquiries within :> minutes. Special stud; i^ undertaken to adopt remedial measures in the case of routes where the efficiency is low. Supervision has been tightened to improve the working with the result that effective percentage Of calls has gone up by about 12%.

<b) It was suggested by one of tlie Ministers that the promotion of fertilizers would he facilitated if the prices of fertilizers were kept to the minimum possible inter-alia by abolishing the excise duty on fertilizers.

<c) I lit use of fertilizers is considered profitable enough to cover the present cost of fertilizers. It is hoped that the cost of production and hence the prices would come down with the establishment of larger fertilizer units.

DROUGHT CONDITIONS IN NORTHERN INDIA

ANNASAHEB SHINDE): (a) and (b) No, Sir. The South West Monsoon which is important for the sowing and growth of kharif crops started early or in time this vear. Total rainfall during the current monsoon, upto 12-8-1970, was normal, except in the Bihar plateau in Northern India. However, there have been spells of deficient rainfall particulariv in lulv in some regions of Punjab, Harvana, Bihar and Uttar Pradesh. Some areas in western Rajasthan also were affected by an intervening dry spell and sand storms. In Jammu & Kashmir, snow and rainfall are
