(b) and (c) The estimate of production given in Part (a) above is a gross figure. For the purpose of consumption needs, the net figure has to be taken after allowing for feed, seed etc. Again, the total figure of production includes not only cereals but also pulses. Further, the average consumption of foodgrains in India at present is much higher than one quintal per head per annum. On the basis of the average food consumption, the country has not yet attained self-sufficiency.

#### **STRIKE BY THE STAFF OF COCHIN PORT**

328. SHRI R. HILLAI VILLALAN: Will the Minister of LABOUR AND REHABILITATION be pleased to state :

(a) whether it is a fact that the supervisory staff including foremen, riggers

and chargemen of the Cochin Port were on strike in the first week of July, 1970; and

(b) if so, what are the reasons therefor?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI D. SANJIVAYYA): (a) and (b) About 100 riggers and 40 foremen were on strike between July 6 and July 9, 1970 on a demand for implementation of the recommendations of the Central Wage Board for Port and Dock Workers.

#### **UNDERESTIMATION OF FOOD PRODUCTION**

329. SHRI SITARAM JAIPURIA: SHRI BHOLA PRASAD:

Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether it is a fact that food production in the country is being underestimated by at least two or three million tonnes per year;

(b) if so, the reasons for the underestimation ; and

(c) the steps taken or proposed to be taken for correct estimation of food production ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) The All-India Estimates of Foodgrains production are compiled taking into account the State-wise estimates furnished by the State Governments. The estimates furnished by the State Governments are scrutinised in the Ministry and as realistic estimates of foodgrains production as possible are formulated at the All-India level. However, while releasing the All-India Final Estimates for 1967-68 and 1968-69, it was mentioned that keeping in view the coverage under high-yielding varieties programme and the increased inputs, the Estimates worked out might be slightly under-estimates.

(c) Estimates of production of foodgrains crops are derived as a product of area under the crops and their yield rates. Area estimates are based on complete field-to-field enumeration by the Primary Revenue Agencies except in Orissa, Kerala, and West Bengal, where

acres are estimated by means of random sample survey. Estimates of yield rates are arrived at on the basis of crop cutting experiments in randomly selected fields. Attempts are being made to improve the reporting of the estimates and reduce the time-lag. A Centrally Sponsored Scheme, for Timely Reporting of Estimates of Area and Production of Principal Crops has been initiated in the four States of Maharashtra, Uttar Pradesh, Bihar and Mysore. The Scheme will be extended gradually to other States during the Fourth Plan. Steps are also being taken to integrate the field programmes of National Sample Survey-Land Utilisation and Crop-cutting experiments Surveys, State Crop Estimation Surveys and the Timely Reporting Scheme with a view to increasing accuracy and timeliness of area and yield statistics of crops in the country.

#### **SECOND WAGE BOARD FOR SUGAR INDUSTRY**

330. SHRI N. R. MUNISWAMY: Will the Minister of LABOUR AND REHABILITATION be pleased to state the details of the recommendation of the Second Wage Board in the sugar industry?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI D. SANJIVAYYA): Copies of Government's Resolution No. WB-7(q)/70 dated the 7th July 1970 announcing decisions on the Wage Board's report were placed on the Table on 11th and 27th July, 1970. The Resolution also contains a summary of the Board's conclusions and recommendations.

#### **DEMONSTRATION BY THE EMPLOYEES OF P. & T. DEPT., MADRAS**

331. SHRI N. R. MUNISWAMY: Will the Minister of INFORMATION AND BROADCASTING AND COMMUNICATIONS be pleased to state:

(a) whether Government's attention has been drawn to the demonstration on 3rd July, 1970 by the staff of Postmaster General, Office and Telephones Department, Madras protesting against some of the recent administrative measures taken by P & T Board; and

(b) if so, what are the reasons for such measures?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS

(PROF. SHER SINGH): (a) No previous information was received from any quarter regarding demonstrations on 3rd July, 1970. There were, however, demonstrations in front of the office of Postmaster General, Madras for about 5 minutes during lunch interval. There were also demonstrations in front of the office of the Divisional Engineer, Telegraphs, Tirunelveli, after office hours.

(b) The purpose of demonstrations appears to be protest against the increased workload, meagre promotional avenues and non-restoration of pre-emergency working hours.

#### **PARTICIPATION OF WORKERS IN THE MANAGEMENT**

(c) if the reply to part (a) above be in the negative, the reasons for the delay?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI D. SANJIVAYYA): (a) to (c) Details of the proposal are under examination in consultation with the Ministries concerned.
