State Governments that concerted effort* should be made to improve the competence and scale of extension agents at all levels endeavour should be to meet the needs of particular areas for extension services with higher expertise than the minimum universal standard. The Conference of Chief Ministers and State Ministers for Community Development and Panchayati Raj which met in Madras in June. 1968 recommended that the changes in the organisational pattern of the blocks should be brought about taking into account the actual programme potential and workload from area to area. It was also suggested that functionaries who were not likely to have enough work in a given area may be re-employed. Improving extension services is a challenging task and taking into account the magnitude of the work involved the number of extension staff made available to a block is limited. Figures of annual expenditure alone are not a good guide to the requirement extension services.

(d) The work of Block Officers in the States is looked after by the Block Development Officers except in Madhya Pradesh where it is looked after by Development Assistants.
