IRON ORE FOR BHILAI STEEL PLANT

- (a) whether it is a fact that iron ore for Bhilai Steel Plants is being brought from Barbil|Banspani(Orissa);
- (b) if so, the reasons therefor and what is the utility of the mines of the Bhilai Steel Plant; and
- (c) whether all the Blast. Furnaces of the Plant are working and if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF STEEL AND HEAVY ENGINEERING (SHRI MOHD. SHAFI QURESHI): (a) and (b) The captive mines of Bhilai Steel Plant had so far been meeting the requirements of iron ore for the plant. However, recently the plant had to obtain about 88,000 tonnes of iron ore from Barbill Banspani mines to meet temporary shortage of ore caused by fall in production of ore in captive mines due to

exodus of labour, non-availability of certain equipment.

(c) One of the Blast furnaces was under relining from 16th April to 14th August, 1970. However, since 15th August, 1970 all the furnaces are in operation.
