SHRI ARJUN ARORA: I am asking a question, but half a dozen Members get up every time. My question is whether under the scheme it was open for Mrs. Aruna Asaf Ali, an Indian citizen, to receive a gift from an Indian abroad because she claimed that she received money from an Indian national abroad.

## (Interruption)

MR. DEPUTY CHAIRMAN: Second question ?

SHRI ARJUN ARORA: Another brief question is whether any other Indian national who received foreign remittance under this scheme disclosed the name to the Government or to the public; if not, why should Mrs. Aruna Asaf Ali alone be singled out for this disclosure in spite of the fact that in her generosity ...

### (Interruption)

SHRI SHEEL BHADRA YAJEE: He is a reactionary.'. .

SHRI LOKANATH MISRA: You are a Russian agent . . .

SHRI BHUPESH GUPTA: Mr. Piloo Mody is whose agent?

SHRI ARJUN ARORA: I want to know whether any other Indian national except Mrs. Aruna Asaf Ali was generous enough and frank enough to offer to any agency of the Government the name of the person who sent the remittance.

Thirdly, . . .

MR. DEPUTY CHAIRMAN: No third auestion.

SHRI BHUPESH GUPTA: When again and again I wanted to place it, you do not even allow me.

SHRI R. K. KHADILKAR: While replying to the Leader of the Opposition I made the position very clear. He has repeated the question in a different form. Under the scheme when a remittance was received, the receiving party was Under no obligation to disclose the name. This is number one- Regarding the second question whether others have also disclosed these things, I do not know, but the income-tax authorities must be having that information. If have no information. If the House wants it, I shall give.

SHRI ARJUN ARORA: Sir, I seek your protection . . .

## THE ASSAM REORGANISATION (MEGHALAYA) BILL, 1969

MR. DEPUTY CHAIRMAN: Mr. Shukla.

SHRI C. D. PANDE (Uttar Pradesh): Sir, on a point of order. The item that the hon. Minister is to move cannot be taken now at such short notice.

MR. DEPUTY CHAIRMAN: Let him first say what he wantr. to say. Afterwards you can raise a point of order.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) Deputy Chairman, I seek your indulgence and the indulgence of the House to move this motion for consideration. Although this item is not on the Order Paper, with your indulgence and the support of the House I would like to move the motion: "That the Bill to provide for the formation within the State of Assam of an autonomous State to known as Meghalaya and for matters connected therewith, as passed by the Lok Sabha, be taken into consideration.

SHRI S. N. MISHRA (Bihar): Mr. Deputy Chairman, may I say that probably all of us are very much interested in the expeditious passing of this measure. Let there be absolutely no doubt about it, but at the same time this must be made clear beyound any shadow of doubt that we cannot put up with the cavalier fashion in which this House is sought to be treated. We cannot be at the beck and call of the Government and we cannot just to enable the Government to go to Bombay, get this legislation for Meghalaya passed in an irregular way. If we had to do it properly, we would have sat for a day more beyond the 24th.

Another point. This cannot be taken up like this. We are governed by certain rules of procedure. The rules of procedure do not permit this motion to be made in this way and so I must say that some

one must educate the Government on the way in which such things are to be placed before the House. The fu st step in this connection should be that the relevant rules should be suspended. Now that has not been done, that is not being done. Can Ih's tlung be smuggled in like this? The mles have to be waived. Secondly it must be made clear again that if the rules have to be suspended it should be with the approval of the House and not with the consent of the Chair. I am not going to have the element of the C02iseut of the Chair in future. I would certainly have the rules suspended but the element of the consent of the Chair I am not going to consider ia future. It has to be

SHRI BHUPESH GUPTA (West Bengal): He has made a very important point. The rule has to be suspended, let us suspend it. But I must say we also approached, some of us approached the Government to pass a Bill on the same day. Therefore, I think you should not insist. First of all, it should not be normally a precedent. Secondly\*

SHRI S. N. MISHRA: Please wait. The point is this that if today you get the rules suspended with the consent of the House, with the approval of the House, then in future also we will follow it. This should be done, because it would appear that if the Government comes forward with this, therefore, they get the approval of the Chair. If S. N. Mishra moves for the suspension of the rules, there cannot be any discrimination between the Government and S. N. Mishra. That is the point which I would like to make for your consideration.

(Shri C. D. Pande stood up)

MR. DEPUTY CHAIRMAN: Mr. Pande, you have already made your point.

MR. DEPUTY CHAIRMAN: Mr-Pande, what do you whant to say now?

SHRI C. D. PANDE: Sir, an important point has not been covered by hirn.

SHRI MULKA GOVINDA REDDY (Mysore): We are all for passing this Bill. Let there be no doubt about it. What we ar' objecting to is the way in which the Government is behaving ir. this matter. There are many important Bills and this is one such important Bill. Many Members ave interested in debating over this Bill. They cou'd have brought it before this House before they took it to the Lok Sabha. After we had passed it, they could have taken it there.. •(Interruptions). There were important discussions there. By that time we could have discussed and debated it. Firstly, there are two points involved. One is suspending the rules peimitting the moving of this Bill. We have no objection to suspending the rules. But we have really to debate over this Bill and as Mr. Rajnaraiii said, there is tlie name of the new sub-State that they are going to create and other things, because it will have serious repercussions over the entire country. So. rushing through this Bill is not very fair. But we all agree that this should be passed. We would like to suspend the rules. We lend our support for pissing this Bill.

SHRI BHUPESH GUPTA: Everybody has said about it. I think it is a genuine desire that we have expressed. Mr. Mishra has done it. I would have also been against taking it up to day. But this Bill has an origin a:id his', ry-Most of the parties represented here, practical'y all the major parties in India, discussed this matter, and the Bill, I understand, is the result, the product, of such a discussion between them on the one hand and the hill leaders on the other. It has been gone through. If I have not gone through it, my party people have gone through, the PSP has ■•-gone through, the Congress Party has gone through, the Swatantra Party has gone through, at the various levels of discussion. And it is the desire of the hill people. They are looking forward to us. I think, in view of this thing, you can make an exception, if you like, and we can have it passed. As far as the names and others are concerned, surely, Mr. Deputy Chairman, in the other House nobody has amended them...

(Interruptions) Let me say. Now all the parties are represented there. Whethe "we have reservation or not, every party thought and agreed that the Bill should be passed unamended because it embodies a great measure of agreement among the parties. Therefore it has gone through the second test of all-party examination in the Lok Sabha. Therefore, we should have no difficutly, at least in this case, having regard to the fact that we are adjourning today. It is unreal that tomorrow you meet. Then it will not be passed...

SHRI DAHYABHAI V. PATEL (Gujarat): Why not? Why is it unreal?

SHRI BHUPESH GUPTA: It is unreal. You know it very well... (Inttrrvp/imis) All right. If the Government wants to sit the day after tomorrow, I have no objection. But why can't we pass it today and save a little time? If you like, tomonow is all right.

SHRI C. D. PANDE: The day after tomorrow.

SHRI BHUPESH GUPTA: My friend' Mr. Rajnarain, is a very able leader and he understands things very quickly. If he speaks a little less and he can finish in five or ftf'een minutes, I am sure he will be able t.i make a good speech and we can manage.

SHRI C. D. PANDE: This is a very important Bill. We want that this Bill should be passed. But to bring in a Bill of this nature at quarter to seven and to expect that we shall pass it within one hnur at so, it is really rediculous and it is ni insult to this House because in the Lok Sabha this Bill was fully discussed. Of course, it has been said by Mr. Bhupesh 'Gupta that this thing has been in the country for a long time. But inspite of tliat also, the Lok Sabha took almost 11 hours to discuss this Bill, for two days. Do you know when this Bill . . . .

SHRI OM MEHTA (Jammu and Kashmir): No, no. There were many other discussions.

MR. DEPUTY CHAIRMAN: Many more subjects were discussed.

SHRI C. D. PANDE: They took two days. It wAi discussed there the d''.y before yesterday and today. How many hours? Half the time of that House . . .

THE LEADER OF THE HOUSE (SHRI K. K. SHAH): I was only then requesting the House. I thought that the House was good enough to accede to my request, that I have

SHRI OM MEHTA: Mr. Pande. three hours.

SHRI K. K. SHAH: I have brought it because I thought that my request was accepted by the House. If the House is not willing, then I will not move it. But I thought once my request will be accep'ed by the House.

SHRI C. D. PANDE: Even if there is one Home Minister here and you all go to Bombay, we will pass this Bill without delay on Friday because we have made up our minds that we want to give autonomy to that part of the country. But to hurry up like this is not good . . . (Interruptions) I want to speak.

MR. DEPUTY CHAIRMAN: Order please.

SHRI G. D. PANDE: Within one hour we ennnot finish this matter.

SHRI OM MEHTA: The Lok Sabha took in all three hours. For Christmas mw/ Members would like to go to their homis. It is not fair that we should detain them from going to their homes.

SH AI DAHYABHAI V. PATEL: It must be done in a proper way, a proper motion for suspending the rules must come up. We will not be hurried. Firstly, the proper motion should be there to waive the rule.

SHRI BHUPESH GUTA : He is right. I move :

"That the rules be suspended."

MR. DEPUTY CHAIRMAN: There are two things. If the rules are to be suspended, firstly I have to give consent and secondly, if we have to decide on that motion, then we have to take the sentiments and the wishes of the House...

(Interrt/ptiovs)

SHRI K. K. SHAH: If you are agreeable I am moving.

MR. DEPUTY CHAIRMAN: I give my consent to move the motion for suspending the rules and now after that I would try to assess the feelings of the hon.

Members and then we can decide whether we can take up this Bill for coasideration or not.

SHRI S. N. MISHRA: I have only one submission to make.

MR. DEPUTY CHAIRMAN: You can speak on the motion now.

SHRI S. N. MISHRA: No motion yet. . .

SHRI BHUPESH GUPTA: Sir, I have already moved:

"That the House resolves the Rule 123 of the Rules of Procedure and Conduct of Business in the Rajya Sabha be suspended for the day."

SHRI S. N. MISHRA: A motion can be moved only with your consent. I am sorting out the issue. I am making a submission which would help you in the conduct of the business, it will not delay matters. The point is that—it should again be made clear—this Bill is being hustled through today. We were prepared to sit. day after tomorrow . . .

SHRI AKBAR ALI KHAN (Andhra Pradesh) . No, no.

SHRI S. N. MISHRA : Mr. Khan, please hear me. :

MR. DEPUTY CHAIRMAN: Please be brief.

SHRI S. N. MISHRA . . I am completing. We are being put to great inconvenience. In fact, the dignity of the House is being diluted. I have to speak with a certain sense of responsibility in this matter. The question is that we were prepared to sit day after tomorrow. Now the plea of Christmas is being made. Where was Christmas last year? I remember we sat till the 28th December and no Christmas came in our way. It is the Bombay session that ir. coming in their way. The point is that it is their party affair and not the religious sentiment, which is coming in the way of the full consideration of the measure. Even so, we shall submit that if you want the rule to be suspended, the suspension will be with the approval of the House and this matter wil1 then be treated as a precedent. We are not going to treat it as an exception.

SHRI BHUPESH GUPTA: To be exact, I

"That the House resolves that Rule 123 of the Rules of Procedure and Conduct of Business in the Rajya Sabha be suspended for the day."

SHRI K. K. SHAH: If it is going to be a precedent, then we are not prepared.

BHUPESH GUPTA The Government should not back out. I have moved the motion only. I have not said any other thing . . .

MR. DEPUTY CHAIRMAN: Will you please take >our seat? I am speaking. This situation has arisen today because of some unforeseen circumstances. This Bill would have been passed by the L:>k Sabha, I think yesterday, and then it would have been placed on thfjtable of the house and we would have taken it up for consideration after giving due notice to the hon'ble Members. unfortunately one hon'ble Member of the other House expired the other day and that is why this Bill could not be passed by the other House. And without their passing it no Message could be received in this House. Therefore, we have to consider whether this Bill should be taken up now after waiving the rule. In view of this condition we have to . . .

SHRI BHUPESH GUPTA: They must not back out.

MR. DEPUTY CHAIRMAN: If we have to take it into consideration we have to see whether this should be an exception or this should be a precedent. . .

SHRI BHUPESH GUPTA: With the approval of the House . . .

MR. DEPUTY CHAIRMAN: Mr. Bhupesh Gupta, I am speaking. Let me speak first. The waiving of the rule can be decided by the general consensus of the House because it is provided in Rule 267:

"Any member may, with the consent of the Chairman, move that any rule may be suspended in its application to a particular motion before the Council and if the motion is carried the rule in question shall be suspended for the time being.'

[Interruption by Kumari Shanta Vashist]

When I am speaking you should not stand up. I am clarifying my point of view . . . [Interruption hy Shrimati Vdiyawati Chaturvedi) Will you please keep quiet?

SHRI BHUPESH GLPTA: The hon'ble Minister has asid many things. We have salo said so many things. You need not take all these things into account. All that Mr. Mishra has said is important. All that you are concerned with is whether the House desires this Bill to be passed '.oday. The procedure lays down that in such cases a particular rule has to be suspended and that cannot be done without your consent. The Government or the Opposition does not come in. They will come in only when you give the consent to vote on it. You see we are all desirous, whatever our reservations, to pass this Bill, and giving to the Assam people what they want. Therefore, Sir, I want your guidance, direction and permission in deference to the wishes of the House that you be good enough to permit me to move this motion. If it is rejected, the question does not arise. If it is accepted only then we shall pass this Bill. That is the only way.

SHRI AKBAR ALI KHAN: I would request you to take the vote as you have already given your consent.

SHRI S. N. MISHRA . Only one submission. I think triat you have tried to be fair to us but you have not succeeded

ir. being very fair to us. My point is this that the Government's point can of course be explained by you in a very s?tisfcatory manner. So far as the measure is concerned, we are all anxious that it should be psssed. It is not only because of some deaths or some unforeseen circumstances which occurred in the other House that we ire finding ourselves in difficulty; perhaps we wiuld have been out of this difficulty if the Government were prepared tosit day

after tomorrow. Let it be clear tliat 7 P.M. in matters of analysis I would not

SHRI BHUPESH GUPTA Government will be responsible for not passing il.

SHRI S. N. MISHRA: No, no. Please do not give any reasons.

MR. DEPUTY CHAIRMAN: In view of the importance of tha matier, I am giving my consent to move the motion.

SHRI RAJNARAIN: You are in the hands of the Government . . .

MR. DEPUTY CHAIRMAN: I have given the consent in view of the exceptional circumstances and this will not be treated as a precedent in future. Also I would like to urge the treasury benches to try to arrange their legislative business in future in such a manner that there will be no necessity to waive the Rules of Procedure.

SHRI BHUPESH GUPTA : So, Sir, with your consent, I beg to move :

SHRI AKBAR ALI KHAN : Sir, I second it.

श्री राजनारायण : सुना जाय । वे सेकिन्ड भी कर रहे हों तो भी मुझे बोलने का हक है। चुंकि भूपेश गुप्त ने जो प्रस्ताव पेश किया है उसकी आपने आज्ञा दी, तमाम संसदीय पर-म्पराओं को तोड़ा, तमाम सभ्य तरीकों को दफनाया, अपनी आज्ञा प्रदान की सरकारी दल के फायदे के लिये, इसलिये जब सभी अनिय-मितताएं हो रही हैं, तो भूपेश गुप्त के प्रस्ताव का मैं समर्थंन कर रहा हूं ताकि एक अनिय-मितता और भी हो जाय और भूपेश गुप्त प्रसन्न हो जायं कि इन्होंने बड़ा आसाम के लिये तीर मार लिया । भूपेश गुप्त यहां 1952 से हैं। मैंने बराबर इनकी तारीफ की है, ये संसदीय नियमों के ज्ञाता हैं, लेकिन जिस ढंग से इन्होंने कृतघनता का कार्य किया है, संसदीय परम्प-राओं के प्रति वह स्पष्ट है। तो मैं इनके प्रस्ताव का समर्थन कर रहा हूं।

SHRI S. N. MISHRA: Sir, there is no question of a division on this. Since you have said that the Government must not behave like this in future, I would request all honourable Members on this side of the House to support it unanimou-sly.

MR. DEPUTY CHAIRMAN : The question is :

"That the House resolves that Rule 123 of the Rules of Procedure and Conduct of Business of the House be suspended for the day."

The motion was adopted.

SHRI VIDYA CHARAN SHUKLA : Sir, I move :

"That the Bill to provide for the formation within the State of Assam of an autonomous State to be known as Meghalaya and for matters connected therewith, as passed by the Lok Sabha, be taken into consideration."

Sir, as far as this particular measure is concerned, this matter has been debated in the House when the Constitution (Amendment) Bill was to be referred to a Select Committee, and after that the

political parties which are represented in this House have had occasions of discussing this matter at great length.

[THE VICE-CHAIRMAN (SHRI AKBAR ALI KHAN) jin the Chair]

It is also known that the tribal areas of Assam already enjoy a certain measure of autonomy in the Constitution. And therefore, 1 hope honourable Members will extend their unanimous support to this measure which I have had the honour of bringing before this House.

The question was proposed.

SHRI C. D. PANDE: Mr. Vice-Chairman, I wholeheartedly support this measure. But I want to bring to your notice about the situation that is prevailing in the State of Assam because the creation of a new State wil! accelerate division . . (Interruption by Shri Bramananada Panda) You wanted to pass it today itself and you do not want Members to speak on it. How is it?

The situation in Assam is so bad that the do not realize what kinds of people today things happen there. On the one hand there is the infiltration of foreign people. There is disintegration all round. There is a feeling of animosity or enmity between different communities and people belonging to different linguistic groups. And even the Assamesespeaking people are getting resitive. I will give you one example. I will also tell the House how the Government is helping those tensions there. There was strike, there was a movement in Assam, for a second oil refinery. There was a great agitation. Almost one lakh or more people courted arrest and went to jail. But how did the Government solve that issue? matter of real shame for all of us that the Government took such steps to appease the people on false promises. Their pro was that they would give them refineries. May I know from promise Government whether there is enough crude in the State of Assam, whether Government has found new wells so that Assam could get three oil refineries?

THE VICE-CHAIRMAN (SHRI AKBAR ALI KHAN): But we are not dealing with its oil refineries.

SHRI C. D. PANDE: No, no. This Bill will have its repercussions on the newly created State. Assam is already a State. The easiest method to appease

the people was to promise them a second refinery in Gauhati itself. Now there are two refineries, one at Barauni and one at Gauhati. Now, you promise a third refinery by which for the time being you appease the people of Assam. Thus you are winning over their upport to the Government. But is it sproper that you promise a thing which you cannot fulfil? (Interruptions) Either you close the refinery at Barauni or you deprive the crude to the other plants. If the two factories are fighting for full capacity for their production, how do you feed the third plant? This is a very important question.

The second thing is about the composition of the people. This House has always been reminding the Government that a large number of people are coming there from other parts of the country. If people from ill other parts come there, then, Assam will fall like a ripe mango because you are not giving proper attention to the development of Assam. You are simply tossing up its problems from day to day. I have given you one example, that is the policy of appeasement, appeasement on false promises, appeasement for petty pnrposes, fo- getting the temporary support of the people. This is the feeling there. All the same I support this Bill and I wish all prosperity and all-round development to the people of Meghalaya. They have chosen a nice name, Meghalaya. That shows how they owe their allegiance to the Indian culture. They are part of the Indian people. I hope they will succeed in their efforts for development and they will prosper. . , .

SHRI MULKA GOVINDA REDDY: Mr. Vice-Chairman, on behalf of our party I support the Bill that has been placed before us. This is a very important measure and we are granting autonomy to a section of our own

We do want a contented people. They should have the freedom to shape their own lives according to their own likes. And we have recognised that. It is a very important centre no doubt, a very strategic centre. Now that we have granted with the willing consent of all concerned a State within the State of Assam, I hope

the hill people will fully cooperate and the Government of India should not lag behind in giving encouragement all for develoomeni, economic, social and cultural. We wish them well, and I hope that the Indian Union will be intact and nobody will ever think of dividing this country. Th/y are all Indians. They are all patriots. And for the freedom and glory of the country they will all work hard.

श्री राजनारायण : श्रीमन्, जैसा कि मैने पहले अपने भावों को व्यक्त किया था, मुझे खुशी है कि इस वक्त श्री यशवन्तराव चव्हाण भी यहां पर विद्यमान हैं - मैं यह समझ नहीं पा रहा हुं कि मेघालय नाम इसका क्यों रखा गया । जरा मैं इसको जानना चाहता हुं कि मेघालय नाम क्यों रखा गया । चुंकि हमें ऐसी स्थिति में ला कर रख दिया गिया है कि हम इसमें अमेंडमेंट भी मुव नहीं कर सकते, हम इस विधेयक को इम्प्रुव भी नहीं कर सकते; क्योंकि जो 48 घंटे का समय होता है, वह इस लिये होता है कि उसमें हम विधेयक की धाराओं को पढ़ें और उसको जहां तक तरक्की के रास्ते पर ले जा सकते हैं, ले जांय, लेकिन आपने वह समय नहीं दिया, आपने खुद इस नियम को ससपेंड करने का प्रस्ताव लाने की आज्ञा दे दी तो यह सारा दोष जो कुछ भी होगा वह आप पर जाता है, यानी अगर आसाम की जनता और देश की जनता का और राष्ट्र का इस विधेयक से हित हो तो बाहवाही और अगर इस विधेयक से अहित हो तो उसका सारा पाप आप पर जाय ।

श्रीमती विद्यावती चतुर्वेदी : कड्आ, कड्आ थ्, मीठा मीठा हप्प ।

श्री राजनारायण : हमारी सम्मानित सदस्या श्रीमती चतुर्वेदी जी जब कुछ बोलती हैं, तो मुझे अच्छा लगता है। एक वाक्य बड़े आदमी का मैं इसी लिये पढ़ देना चाहुंगा । श्रीमन, मैं चाहंगा कि श्री यशवन्तराव चव्हाण भी उसको सुन लें। जरा सुनें। कभी ऐसा मत बोलना कि देशद्रोही देश को बर्बाद करता है। देशद्रोही तो अपना काम करेगा ही, लेकिन अगर जनत सचेत है तो देशद्रोही को पकड़ कर के उसक

काम खत्म करती है और अगर जनता उदा-सीन हो जाती है, तो देशद्रोही अपना काम पूरा करता है। यह डा॰ लोहिया का वाक्य है। इसी तरह से इसमें एक वाक्य मीठी बात के बारे में भी है और खरी बात के बारे में भी है। वह यह है कि मीठी बात करने वाला अपने वेई-मान इरादों को मीठी बात में दबा देता है और खरी और तीखी बात करने वाला अक्सर ईमान-दार होता है। तो यह मत समझो की लाई-लुई बात जो करते हैं वही ठीक है, खरी बात, सही बात भी जो कहे उसको भी जरा सुना करें।

श्रीमन, मैं आसाम गया हं, आसाम की सम-स्याओं को कुछ समझने की कोशिश भी की है, कर रहा हुं और करूंगा। जब यहां पर पंजाब का विभाजन हो रहा था, पंजाब और हरियाण में तब हमने एक वाक्य कह दिया था कि जब देश पर विदेशी सत्ता थी तो विदेशी सत्ता से देश को मुक्त कराने के लिये हमने सब कुछ कुर्वानी की मगर जब देश आजाद हुआ, तो कौन हिस्सा कहां जायें और कौन हिस्सा कहां रहें, इसमें हमें अपनी माथा-पच्ची नहीं करनी है। श्रीमन, मैं देख रहा हूं कि चंडीगढ़ के सवाल को ले कर आज क्या हो रहा है। पता नहीं कि इसकी आखीरी शक्ल क्या होगी। उसको छोडिये । यहां आसाम की बात है । मगर हमारे आसाम से जो मिल आते हैं, श्री गोलप वार-बोरा, यह हमारे दल के सदस्य हैं और यह हमको बैठा कर के समझा रहे थे कि इससे पेची-दिगयां भी पैदा हो सकती हैं, इससे समस्या का समाधान हो ही जायगा, ऐसा नहीं कहा जा सकता ।

श्री एम० पुरकायस्य (आसाम) : हो ही जायगा ।

श्री राजनारायण: तो इन तमाम वातों के साथ मैं आपके जरिये घर मंत्री को इतनी वात जरूर कह दूंगा कि हम इस विधेयक का समर्थन करेंगे, इस विधेयक के साथ रहेंगे, क्योंकि जहां पर देश का सवाल हो जाता है, वहां देश हित की रक्षा करना हमारा कर्तव्य हो जाता है, सरकार कहती है कि इससे देश का हित होगा, तो हम अपनी शंका को व्यक्त करते हये इस विधेयक का साथ दे रहे हैं। हमको इसको इम्प्रव करने का वक्त नहीं मिला। हम इस विधेयक को इम्प्रव कैसे कर सकते हैं, जब कि अमेंडमेंट आपने आने नहीं दिया । कहा गया कि अमेंडमेंट आपने क्यों नहीं दे दिया लेकिन यह तो कोई पागल ही बोल सकता है कि आपने अमेंडमेंट क्यों नहीं दे दिया, क्योंकि जब लोक सभा से आखीरी शक्ल में विधेयक आ जायगा, तभी तो हम संशोधन देंगे या उससे पहले दे देंगे कि जो हमारे पास पहले विधेयक चला गया उसी में अमेंडमेंट दे दें । यह पगल्सपन की बात है, उन लोगों की बात है जो कि संसदीय प्रथा से अनभिज्ञ हैं।

श्रीमन्, अब प्रश्न यह उठता है कि इसका नाम घनालय क्यों न हो, मेघालय क्यों हो।

श्री क्षीलनद्र याजी (बिहार) : क्योंकि वहां बारिश ज्यादा होती है, इसलिये मेघालय नाम पड़ा ।

श्री राजन रायण: ये बेचारे भारतीय संस्कृति और भारतीय शब्दों से इतने अनिभन्न हैं कि इनको मेघ और घन का फर्क नहीं मालूम । तो घनालय क्यों न हो ?

डा० हरिवंश राय बच्चन (नाम-निर्दे-शित) : कालिदास ने घनदृत क्यों नहीं रखा, मेघदूत क्यों रखा ?

श्री राजनारायण : सही है, ठीक है, चूंकि हमारे एक कवि जी बोल रहे हैं, हिन्दी साहित्य के विद्वान हैं।

उपसभाष्यक (श्री अफबर अलीखान) : अब तो मान जाइये ।

श्री राजनारायण : मैं उनसे कहना चाहता हूं कि कालिदास ने जहां मेघ शब्द रखा है, वहां घन शब्द क्यों नहीं रखा ? कालिदास के मेघदूत का जो अनुवाद है वह मैं पढ़ रहा हूं। मुनिये ।

"धाम धूम नीर औंसमीरन को सन्निपात, ऐसो जड़मेघ कहा दूत काज करिहै । नेह को संदेशो हाथ चातुरे पठैबे जोग, बदरा बिचारो कौन भांति सो उचरिहै । बाढ़ी उत्कंठा यक्षबृद्धि विसरानी सबै, बाही सौ निहोरे जानि याते काज सरिहैं। काम के तपाये मित हीन हैं सदा ही तिन्हें, चेत और अचेत कहा भेद जानि परिहें।

डा० हरिवंश राय बच्चतः घन के साथ घमंड लगा हुआ है। "घन घमंड बरसत नभ घोरा।"

श्री राजनारायण : सुनिये। " घन घमंड बर-सत नभ घोरा, प्रिया विहीन डरपत मन मोरा।"

तो मैं यह कहना चाहता हूं कि इसका नाम घनालय हो. वहां से घमंड इतना गरजे कि कोई भी बाहरी शक्ति, बाहरी सीमा की शक्ति, इधर आंख लाल करने की हिम्मत न करे। हमारे कवि ने हमारी बात का समर्थन किया है। उन्होंने कहा है कि धन गब्द से ताकत का इज-हार होता है, शक्ति का इजहार होता है। तो मेघ पिया के मन को मोहता है और घन दृश्मन के घमंड को चुर करता है। यह दोनों में फर्क है और इन दोनों के फर्क को समझा जाय। और इस समय यह सदन पिया-मोहक बन रहा है. यह सजनी सरकार आज चल रही है, इस सजनी सरकार ने हमारे देश को कहां ले जा कर छोडा है। मैं आज बहुत ही प्रसन्न हूं कि हमारे कवि ने हमारी मदद में वह बात कही जिसको कि मैं कहना चाहता है।

उपसभाश्यक्ष (श्री अकबर अली खान) : अबृतो खत्म करिये।

श्री राजनारायण : हम अब भी चाहते हैं कि सरकार इसको सोचे और वहां के लिये मधुर नाम न रखें । इसलिये हमने पहले ही कहा कि जहां दुश्मन हो वहां मधुर वाणी दुश्मन के पापों और कलुषित कामों को छेद नहीं सकती है, इसलिये वहां घनालय की आवश्यकता है,

वह अनना घन बरसा कर दुश्मनों के मस्तक को चर करे। इसलिये इस विधेयक का नाम ऐसा हो कि जिस नाम को सुन कर के लोग समझ जायं कि यह क्यों बनाया जा रहा है। मैं आपको यह भी कह दूं कि यहां आज भी कुछ वंश परम्परा के गुलाम हैं, खानदानी गुलाम है। भें कहता हूं कि एवरेस्ट गिरि है, उसको हम एवरेस्ट गिरि कहते हैं, लेकिन वह एवरेस्ट गिरि नहीं है, उसका नाम है सरगामाथा। बहां की जो पब्लिक है वह उसको सरगामाथा कहती है यानी सरग पर ले जाने वाला मस्तक, तो यह बिलकुल अच्छा नाम है।

फिर भी आखीर में हम इतनी बात जरूर कहेंगे कि अब की बार इस विधेयक में सरकार ने थोड़ी सी अवल लगाने की कोणिश की है, इसने एक भारतीय नामकरण किया है, वह ठीक है। उसको हम ठीक मानते हैं, और चूंकि हमें इसका विरोध करना नहीं है, इसलिये सदन का ज्यादा समय हम लेना नहीं चाहते और हमको भी जाने की जल्दी है, इसलिये हम भी अब इस विधेयक का आखीर में समर्थन कर के यहां से चले जा रहे हैं। धन्यवाद।

SHRI BHUPESH GUPTA: Mr. Vice-Chairman, now it has been seen how the entire House, especially the Opposition, has been cooperative in this matter but for which we would not have been in a position to pass this Bill.

Mr. Vice-Chairman, we know that we are doing something which is not ordinarily done; we are passing this Bill so expeditiously waiving even the rules for the time being be:ause we want to give legislative expression to the deep urges and sentiments of the hill tribes and the people living in that area. We accept this thing because it is the result of agreement among themselves. The Bill is not just the product of any bureaucracy, is not lhat in Delhi somebody prepared it. Behind it has gone a lot ol' discussion, among various parties, among the plains people and the hills people and, naturally, the discussion has been held under the aegis largely of the Home Minister of the country. Now we need not harp on ihe pas;. There are certain grievances, lacunae and weaknesses which people may find fault with, but th's is the quantum of agreement which we have arrived

[Shri Bhupesh Gupta.] at, and I we should respect that agreement. The importance oi' this measure lies in this that for the first time we are giving autonomy to the tribes or the people living in that area which has been their demand for many many Naturally they are anxious to vears. have this law passed and we are passing it today. It is more or less a consensus in the sense that all those who took part in the discussion, more or less with their reservations here and the-e, came to accept that perhaps this is the best common desideratum for a solution to be arrived at, and naturally we support it. I think, even if we have been denied the opportunity of suggesting a name; which my friend Rajnarain would like to suggest, Meghalaya is a poetic name; recalls to my mind Kalidas, and it is certainly very poetic and good that this name has also been accepted. Now I think that we can accept it.

As far as other amendments are concerned, for the time being we have not got the opportunity to give them but, in future, if it is necessary, I think, again by consensus we can bring forward amendments. But please understand, Sir, that in a matter like this it is not merely putting across my views against some other point of view; in a matter like this involving national integration and also the policy of uplif-ing these people and bringing them closer to us and establishing their rapport, cultural, economic and political, it is also necessary that we have a both-way traffic, that is, exchange of informantion, and agreement arrived at. That is very very essential, and this Bill to that extent represents this consensus and agreement. So we have no difficulty on that score in supporting it. Future will determine as to what amendments we need.

Finally only one thing. I congratulate the people of the hill areas of Assam who have patiently fought for a solution and sought it by democratic means, through peaceful discussions and so on. That is why it has been arrived at, and I think the gesture they have shown towards themselves and to us has tj be acclaimed, and it goes to the credit of the leadership of the hills people that they sought discussion and consultations with those who live in the plains and with the political parties for arriving at a solution of the problem through negotiations, through discussions, through deliberation. And this in itself has to be welcomed. We

assure them of our best wishes and I hop; the Government of India will not lose time in implementing the measure in the spirit in which we are passing it today. AU our hearts go to the people who are living in that area so that they are better integrated and their grievances are removed and they are happy and prosperous. I hops in that spirit it wdl be implemented. Democratic, honest implementation of this measure is of vital importance, not only from the point of view of the people who inhabit that area but of the rest of the country and I would only ask and urge upon thi Government to take immediate steps, after the Bill is passed today. to put it into effect, again with the co-opsration of all those who:,e toil and labour, struggle and sacrifice have resulted in the enactment, of an important democratic, significant measure of this kind.

THE MINISTER OF HOME AFF" AIRS (SHRI Y. B. CHAVAN): <sup>1</sup> am indeed very grateful to this hon-House for the way they not only welcomed this Bill but made it possible to make it a law today. I think this is a recognition of the method of arriving at decisions by agreement and consensus, which the parties concerned undertook.

Sir, this question was pending before the country and the Government for the last nearly eight to nine years. After Nagaland was constituted as a separate State, this demand came tip before the country. And the then Prime Minister of India, Pandit Nehru, accepted the principle of giving them maximum autonomy to these people. Now, this Bill is in fulfilment of that commitment which was made on behalf of the country.

Sir, prolonged and patient deliberations and negotiations and widest possible consultations among the parties concerned were responsible for this agreed solution When we discussed the Constitution (Twenty-Second Amendment) Bill we had gone into the details of the principles involved in it. Sir, this Bill, really speaking, embodies the basic principle of having an autonomous State within the State of Assam. Without bifurcating the State, without disintegrating the State of Assam we have transferred a large number of items—legislative powers—to this autonomous State, and as far as these subjects are concerned, this autonomous State will be treated as a State. The

j Bill is somewhat lengthy because most of the important Articles in the Constitution relating to the State have been incorporated in this Bill. Now. Sir, I am very glad indeed that we are making it possible for tiiis Bill to become an Act today. I recommend that his Bill should be accepted in the spirit in which it has been brought forward. I assure this hon. House that soon after this Bill becomes an Act we will take steps to see that the new autonomous State is constituted. The Parliament has given its best wishes to the people ol' these h'll areas, and I am sure this augurs well for the new
