SHRI A. G. KULKARNI (Maharashtra): Sir, I have to submit to you about certain news that has appeared and that was broadcast by the All India Radio yesterday.

SHRI K. CHANDRASEKHARAN (Kerala): Sir, has the Bombay AICC already begun in this House? He is having a badge.

SHRI A. G. KULKARNI: I am a co-operator. Today is the conference of all-India co-operative executives. Why are you so much shy of the Bombay Congress, I do not understand.

MR. DEPUTY CHAIRMAN: All right. Mr. Kulkarni, you come to the point.

SHRI A. G. KULKARNI: Sir, he wants to know what this badge is. I told him today is the All India Co-operators' Conference where I had gone. Why is he so much agitated about it?

SHRI BHUPESH GUPTA (West Bengal): Actually you should thank him; he has given you a chance to announce about that conference in the House.

SHRI A. G. KULKARNI: My submission to you is there is a deliberate attempt by the All India Radio and certain news agencies to distort the news and to give biased news particularly favouring one party or some other party. Similarly they are shutting off certain news which would have given the correct picture of what happened in the House. Yesterday you are perhaps aware that there was some discussion going on about some question about the shares held by Mrs. Aruna Asaf Ali and my colleague, the hon. Mr. Shejwalkar, made certain remarks; on that occasion I stood up and complained that the Members should not impute any motive to other colleagues that the question is being deliberately delayed. That was my wording. Then, Sir,
