Will the PRIME MINISTER be pleased to state :

(a) what are the names of the industrial and trade establishments connected with the Birla group, the Tata group, the J. K. group, the Goenka group, the Kirloskar group and the Sahu Jain group;

(b) what is the amount of loan and other assistance, with terms thereof, given yearly to each of the said establishments since the year 1956, by the Life Insurance Corporation, the Unit Trust of India, the Industrial Credit and Investment Corporation, the National Industrial Development Corporation, the Industrial Finance Corporation and the Industrial Development Bank; and

(c) what is the position regarding the repayment of loans and interest by these trade industrial establishments ?]

(क) बड़े औद्योगिक समूहों/गृहों से संबंध कम्पनियों के नाम, जिस का उल्लेख प्रश्न में किया गया है, औद्योगिक लाईसेंस नीति विषयक जांच समिति के परिशिष्ट 11 में निम्नलिखित विवरणमें प्रत्येक समूह/गृह रिपोर्ट के सामने दिखाये गये पृष्ठों पर दिये गये हैं। यह रिपोर्ट 21 जुलाई, 1969 को सभा की मेज पर रख दी गई थी।

[THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI P. C. SETHI) : (a) to (c) : A statement is laid on the Table of the House.

STATEMENT

(a) The names of concerns comprised in the Large Industrial group/houses referred to in the question being rather lengthy are not being reproduced in this statement. Details are given in appendix II to the report of the Industrial Licensing Policy Inquiry Committee, laid on the Table of the House on the 21st July, 1969 on pages indicated against each group/ houses in the statement below :—

(b) & (c) The information is being collected and will be laid on the Table of the House. The House will appreciate that since a number of industrial groups and houses, a number of public financial institutions are concerned, and since detailed information has been sought covering" a period of 13 years, its collection will take some time.]

COMPENSATION FOR ACQUISITION OF LAND IN DELHI

*³³⁵. SHRI ABID ALI : Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT be pleased

to refer to the reply to Starred Question No. 196 given in the Rajya Sabha on the 5th July, 1969 and state :

(a) how many persons have not yet been paid the compensation in regard to their acquisition of lands in Delhi ;

(b) how many come under the category of the Court decision ;

(c) when was the decision given by the High Court and Supreme Court respectively ; and

(d) what steps have been taken by Government to regularise the illegal action on the basis of the court decision ?

THE MINISTER OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI K. K. SHAH) : (a) 67 persons have not come forward to receive the compensation. The amounts payable to them have, therefore, been held as a revenue deposit in the Treasury.

(b) 28 persons are affected by the decision of the Supreme Court.

(c) The decision was given by the High Court and the Supreme Court on 25th January, 1966 and 18th November, 1968 respectively.

(d) The matter is still under the consideration of Government.
