(b) It is reported that in a number of developed countries the industrial wastes are generally treated before these are discharged.]

## Soil Erosions

- \*338. SHRI SURAJ PRASAD: Will the Minister of IRRIGATION AND PO-WER be pleased to state:
- (a) what steps are being taken by the Central Government to check Soil erosion due to floods in Bihar and Uttar Pradesh and
- (b) what amount Government have fixed for this purpose in the Fourth Five Year Plan?

THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO): (a) (b) A statement is laid on the Table of the House.

#### STATEMENT

- (a) Measures to check erosion due to floods form part of Flood Control Schemes which are to be undertaken by the State Governments. Individual cases of erosion due to floods in Bihar and Uttar Pradesh are studied by technical experts ard various protective measures such as construction of permeable and impermeable spurs and revetments or strengthening of embankments are undertaken depending upon their effectiveness. The Central Government provides the necessary technical assistance and facilities for model tests as required.
- (b) A tentative provision of Rs. 8 crore each has been decided for their Fourth Five Year Plans for Bihar and Uttar Pradesh for flood control and drainage works which include provision for anti-erosion works.

## STUDY TEAM ON TOWN PLANNING

THE MINISTER OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOP-MENT (SHRI K. K. SHAH): (a) to (c) The Madras Corporation has recently made a suggestion for enacting a uniform legislation for all municipal Corporation in a Civic Address presented to President. Local Government is a State subject and the Government of India has no proposal to enact such a law.
