

LIC LOANS

918. SHRI R. HILLAI VILLALAN : Will the PRIME MINISTER be pleased to state :

(a) whether the LIC is lending loans to Corporations and Municipalities for improvement of towns and also for water supply system in the States ; and

(b) if so, whether any loan has recently been advanced to the State of Tamil Nadu and to Pondicherry and what are the details thereof ?

THE MINISTER OF SUPPLY AND THE MINISTERS OF STATE IN THE MINISTRY OF FINANCE (SHRI R. K. KHADIOLKAR) : (a) The LIC grants loans to Municipalities and Municipal Corporations for their water supply and drainage schemes. It does not grant loans to them for other purposes.

(b) Loans aggregating Rs. 192.33 lakhs have been sanctioned to 28 Municipalities in Tamil Nadu. No such loan has been sought for by Pondicherry.

FOREIGN MARKET FOR INDIAN OIL

(a) whether it is a fact that the Oil and Natural Gas Commission have found a market for Indian Oil in the business market in Europe ; and

(b) if so, the details of the markets so found ?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI D. R. CHAVAN) : (a) and (b) It is presumed that by "Indian Oil", reference is to Oil and Natural Gas Commission's share in the crude oil produced in an Offshore joint venture. A quantity of about 500,000 barrels of this crude was sold by the Oil and Natural Gas Commission to a Spanish refinery in October 1969.

(c) what is the priority date for allotment at present of each type of quarters ?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY) : (a) Yes, Sir.

(b) In all, 2844 quarters, as per the following break up, are expected to be ready for occupation in Delhi/New Delhi by 1971-72 :—
