

run without any collaboration. Triveni Structural Ltd. has been set up in collaboration with M/s. Voest (VEREINIGTE ÖSTERREICHISCHE EISEN-UND STÄHLWERKE AG. LINZ, AUSTRIA) of Austria, who are also participating in the management of the enterprise. The broad lines of the Agreement in the case of Triveni Structural are as under :

(i) The foreign Company shall hold 49% of the subscribed capital of the Company from the time to time—the present authorised share capital of the Company is Rs. 3 crores.

(ii) In consideration for technical assistance, the foreign Company will be allotted free shares to the extent of Rs. 20 lakhs. These will be within the 49% of share capital which they will hold.

(iii) The duration of the agreement will be 20 years or as long as Voest is a Shareholder of the Company whichever is later.

(c) None of the companies have a direct foreign loan.
