the domestic production capacity of urea to meet the growing demand for enhancing the agriculture production in the country. The new policy will enable the enterpreneurs to decide about their investment plans in the fertilizer sector. The new policy will encourage setting up of plants with international efficiency standards for fresh investments in new projects and expansion of existing units. The new and expansion urea units will be based on natural gas/LNG as feedstock which is the most cost effective and the least polluting feedstock in fertilizer sector today.

Policy for debottlenecking/revamp/modernisation of existing urea units for expansion of their capacity has also been announced in . January, 2004. Debottlenecking/revamp/modernisation will be allowed only if the additional production comes from using the natural gas/LNG as feedstock. Under the policy, the measures proposed by the applicant fertilizer units under the debottlenecking/revamp/modernisation of the plant should at least result in 10% increase in the existing urea production capacity.

DAP is a decontrolled fertilizer, and is left to the private manufacturers for their commercial decision in regard to its indigenous production or import. MOP is a mineral fertilizer and its demand is met through imports, as there is no commercially viable indigenous source known in the country.

Supply of DAP fertilizers in Punjab and J & K

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI RAM VILAS PASWAN): (a) and (b) Under the new pricing scheme for urea units which came into effect from 1.4.2003, it was envisaged to decontrol distribution of urea in phased manner. Under the scheme, urea distribution was to be totally decontrolled from 1.4.2004, which has been deferred for a period of one year till end of 2004-05.
