ORDNANCE FACTORIES IN U. P.

1566. SHRI GANESHI LALCHAU" DHARY: Will the Minister of DEFENCE be pleased to state :

- (a) how many ordnance factories are located in Uttar Pradesh which are manu facturing goods for the use of the defence;
- (b) the total number of employees engaged in these factories; and
- (c) the total number of Scheduled Castes and Scheduled Tribes employed in these factories?

THE MINISTER OF STATE (DEFENCE PRODUCTION) (SHRI L. N. MISHRA): (a) There are seven Ordnance Factories located in the State of Uttar Pradesh. In addition to this, there is the Accelerated Freeze Dried Meat Factory in Agra, U.P.

RESERVATION FOR THE MANUFACTURE OF COLOURED SARIES FOR THE HAND-LOOM WEAVING INDUSTRY

- (a) whether it is a fact that the Government of India had issued a notification No. g(42)-Tex(c)/64 dated June 2, 1966 to the effect that the manufacture of coloured saries was reserved for the hand-loom weaving industry and power looms were prohibited from producing them after June 2, 1969;
- (b) if so what action Government have taken in this regard till now; and
- (c) whether any instructions have been sent to various State Governments to implement the decision taken by the Government of India regarding the reservation of coloured saries to the handloom sector?

THE DEPUTY MINISTER IN TI IE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK): (a) to (c) A resolution accepting inter alia the recommendation of the Powerloom Encjui. y Committee to reserve printing of coloured saries for the Handloom Sector exclusively was issued on June 2, 1966. In pursuance of this decision, a Notification was issued on

9th November, 1966, and State Governments were advised to implement this decision.

RISE IN PRICES OF COTTON YARN

THE MINISTER OF STATE (DEFENCE PRODUCTION) IN THE MINISTRY OF DEFENCE (SHRI L. N. MISHRA): (a) The road from Pathankot to Manali *via* Kulu is r n all weather road and fit in all respects for vehicular traffic. Beyond Manali a r;-tricted 3-ton access has been established to Leh. However construction and completion of a number of protective works and temporary bridges is in progress.

(b) The provision of tourist bungalows in the above load is not included in the programme of the Border Roads Development Board.
