**PRICES OF FOOD GRAINS PAID BY FOOD CORPORATION OF INDIA**

**1610. SARDAR HARGHARAN SINGH DUGAL :** Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether it is a fact that in the last Food Minister's Conference an assurance was given by the Union Food Minister that prices already being paid for food grains will be maintained;

(b) if so, whether the price of maize has been reduced from Rs. 54 to Rs. 52 per quintal;

(c) what is the procurement price being paid varietywise for rice from Punjab and what is the issue price varietywise by the Food Corporation of India; and

(d) whether the price difference covers only the actual cost of food Corporation of India or whether it also keeps an element of profit and if so, what is the element of profit ?

**THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE) :** (a) in the last Chief Ministers' Conference it was decided to continue the procurement prices of 1968-69 during 1969-70 with marginal adjustments.

(b) The price of maize has been fixed at Rs. 52.00 per quintal for purchases for the central pool. For their internal purchases the State Governments have been authorised to fix a higher price not exceeding the price fixed for the previous season.

(c) A statement is attached.

(d) The Food Corporation of India is not given any margin of profit for procurement or distribution of food grains on behalf of the Government of

of India. They are only allowed incidentals for meeting their expenditure on procurement, storage and distribution etc of the foodgrains
