THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOY-MENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD): (a) In the Central sphere and most of the States where there is no specific legislation, the Criteria for Recognition of Unions are as in the Voluntary Code of Discipline.

(b) and (c): As far as the voluntary Code of Discipline is concerned, the mangement has to deal with the majority union recognised, subject to certain conditions, for the purpose in an establishment or industry in a local area. The National Commission in Labour has, however, made some recommendations in the matter which are being considered.
