PURCHASE OF ITEMS FROM PRIVATE SECTOR BY DEFENCE MINISTRY

- *117. SHRI BABUBHAI M. CHINAI: Will the Minister of DEFENCE be pleased to state:

THE MINISTER OF DEFENCE STEEL AND HEAVY ENGINEERING (SARDAR SWARAN SINGH): (a) and (b) It has been the effort of Government to utilise every means to become self-sufficient to the maximum extent in meeting the essential requirements of the Defence Services. Whatever Defence items are not manufactured in the Ordnance Factories and the other production units under the Defence complex are either procured from other indigenous sources or obtained by imports.

The private sector is being increasingly utilised for supply of materials for Defence purposes. Procurement of large quantities of Defence materials is being made from the private sector by the DGS & D and the Ordnance Factories. Lists of imported items have been prepared by the Department of Defence Supplies for indigenous development and the Department has been placing orders for many such items on the private sector firms.
