RELAY OF ENGLISH NEWS BY TRIVANDRUM STATION OF ALL INDIA RADIO

355. SHRI K. CHANDRASHEKHA-RAN: Will the Minister of INFORMA-TION AND ROADCASTING AND COMMUNICATIONS be pleased to state:

- (a) whether the Trivandrum Station of the All India Radio does not relay the English News Bulletin at 1.30 p.m.;
 - (b) if so, the reasons therefor; and
- (c) by when arrangements will be made to relay the English News Bulletin by all the Stations in India?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (SHRI I. K. GUJARAL): (a) No, Sir.

- (b) Trivandrum Station relays the Malayalam news from Delhi at 1.20 P.M. It is, therefore, not considered necessary to relay the English bulletin at 1.30 P.M.
- (c) The 8·15 A.M. and 9·00 P.M. English News Bulletins are already being relayed by all stations. There is no proposal for requiring all stations compulsorily to relay all English news bulletins.

EMPLOYMENT FOR BLIND PERSONS

- (a) the number of blind persons who are unemployed in the country; and
- (b) what steps have been taken by the Government of India to provide employment to them?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOY-MENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD): (a) Information about the exact number of blind persons who are unemployed in the country is not available. However, the number of blind persons seeking employment through the Employment Exchanges was 735 as on 30th September, 1969.

(b) The following steps have been taken by the Government for providing employment to physically handicapped persons including the blind.
