FINANCIAL DEMAND OF THE GOVERNMENT OF WEST BENGAL

289. SHRI PRANAB KUMAR MOKHERJEE: Will the PRIME MINISTER be pleased to state:

- (a) whether Covernment of West Bengal has placed a demand of sum of Rs. 10 crores 94 lakhs before a Study Team from the Planning Commission which recently visited the State; and
- (b) if so, what are the reactions of the Government of India thereto?

THE PRIME MINISTER AND MINISTER OF PLANNING (SHRIMATI INDIRA GAN)HI): (a) In their proposals placed before the Central team which visited West Be gal to assess the requirement of funds for flood relief measures, the State Government had estimated the expenditure at ks. 10.33 crores during the current financia year.

(b) On the basis of the recommendations of the Central team, the Govt. of India have adopted a ceiling of expenditure of Rs. 4.76 crores during the current year for purposes of Central assistance. In addition, provided the ways and means situation of the State Government justifies this, loan assistance of Rs. 57 lakhs towards agricultural production schemes, has also been agreed to.

Indian Flag and Photo of Indian Prime Minister burnt in Pakistan

Will the Minister of EXTERNAL AFFAIRS be p eased to state:

- (a) whether the attention of the Government of India has been drawn to the recent Fress reports to the effect that the Indian flag and photo of Indian Prime Minister have been burnt in Pakistan;
- (b) if so, what are the details in this regard; and
- (c) the reaction of the Government of India thereto

THE DEPUTY MINISTER IN THE MINISTRY (IF EXTERNAL AFFAIRS (SHRI SURIENDRA PAL SINGH):
(a) and (b) Yell, Sir. In response to a call by the Muslim and National Students Federations auti-Indian demonstrations

were held after Jumma prayer outside Arambagh and Memon Masjids in Karachi on 3rd October, 1969. At Arambagh Masjid a group of demonstrators, raised anti-Indian slogans, burnt an effigy of Prime Minister and also set fire to the Indian flag.

(c) An emphatic protest has been lodged with the Government of Pakistan, urging them to ensure that adequate measures are taken to prevent the recurrence of such incidents.
