SHRI RAM SAHAI : Will the PRIME MINISTER be pleased to state to what extent there has been an increase in the business done by the Life Insurance Corporation during the period from the 1st April, 1968 to March, 1969 as compared to the corresponding period of the previous financial year and what is the amount that was insured as a result of the increased business ?]

वित्त मंत्रालय में राज्य मंत्री (श्री आर० के० खाडिलकर) : 31-3-69 को समाप्त होने वाले वित्तीय वर्ष के दौरान किए गए नव बीमा कार्य के अन्तर्गत 929 करोड़ रुपये की 14,54,298 बीमा पालिसियां जारी की गईं जब कि पिछले वर्ष 844 करोड़ रुपये की 14,28,043 बीमा पालिसियों का नव बीमा कार्य किया गया था। पूरे व्योरे, जीवन बीमा निगम के 31-3-69 को समाप्त हुए वर्ष की रिपोर्ट और लेखों में उपलब्ध हैं, जिसे 18-11-69 को पहले ही सदन की मेज पर रखा जा चुका है।

### CONFERENCE ON PERSONNEL ADMINISTRATION

(b) if so, what are the major recommendations of the Conference and the reaction of the Central Government thereto; and

(c) whether these recommendations have been brought to the notice of the State Governments for eliciting their reaction ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI P. C. SETHI) : (a) Yes, Sir.

(b) and (c) The Conference did not make any specific recommendations. It was meant mainly to help bring out the various points of views in regard to the Administrative Reforms Commission's recommendations, and to stimulate informal thinking on the subject. As such no recommendations were forwarded to the State Governments.

(c) whether Government consider this increase to be in consonance with its declared policy of reducing dependence on foreign aid;

(d) the manner in which this increase compares with the charges in preceding ten half-year periods; and

(e) what Government propose to do to check this increasing burden of foreign indebtedness ?
