(c) the action taken by Government against their failure to disclose this important information ?

(c) Necessary steps have been taken to tax the income. Penal action has also been initiated and penalties have already been imposed in two cases.

## L.I.C. FIELD WORKERS

(a) whether it is a fact that there has been discontent among the field workers of the Life Insurance Corporation in the Delhi area;

(b) whether it is also a fact that some field officers were recently arrested;

(c) if so, the reasons for their arrest; and

(d) the steps taken by Government to meet the situation?

THE MINISTER OF STATE IN  
THE MINISTRY OF FINANCE  
(SHRI R. K. KHADILKAR) : (a) The Development Officers of the Northern Zone of the L.I.C. have started an agitation against (i) work norms fixed by the Corporation for Development Officers and (ii) the suspension of the Zonal President of the National Federation of Insurance Field Workers.

(b) and (c) On a complaint lodged by one of the Branch Managers of the Corporation that he was manhandled, some of Development Officers in Delhi were arrested and subsequently bailed out.

(d) The work norms are more liberal than the norms recommended by Morarka Committee. Further, the Scheme itself provides for an adequate transition period.
